Pursuant to Condition 7 of the Order Granting Amendment to Condition No. 2 and Addition of New Condition Nos. 3 and 5 filed on February 7, 2011 in State Land Use Commission Docket No. SP70-85, this is to provide you with a report of the following on behalf of the Applicant, Edwin DeLuz Trucking & Gravel, LLC:

1. There has been no material quarried or removed from the quarry since 2007. The quarry is being maintained to supply material for Phase II of the Queen Kaahumanu Road Widening Project which has been delayed.
2. The Applicant is not aware of any public complaints or problems associated with the quarry.
3. The Applicant submitted a request for an amendment to Condition No. 5 of the Order to extend the deadline for submitting a soils report of the mined area of Pu'u Hina'i. The Leeward Planning Commission voted in favor of extending the deadline to one (1) year from the effective date of the amendment and the matter is presently before the State Land Use Commission.
