WHEREAS, on July 16, 1993, Petitioner filed a Motion to Reopen Hearing (hereinafter "Motion") pursuant to Section 15-15-70, Hawaii Administrative Rules;

WHEREAS, on July 16, 1993, and by Order issued on July 23, 1993, the Commission granted Petitioner's Motion;

WHEREAS, the Commission desires to ensure that the hearings conducted in this proceeding shall continue to be orderly and efficient and that the parties are not prejudiced by the submission of exhibits or identification of witnesses at the hearing; and,

WHEREAS, pursuant to Section 15-15-60(b), Hawaii Administrative Rules, the Presiding Officer is authorized to "control the schedule and course of the hearings";


IT IS HEREBY ORDERED, that no later than August 13, 1993, a party shall submit and serve upon the other parties any additional exhibits, memoranda, or other documentary information; and, that no later than August 27, 1993, a party may submit and serve upon the other parties any exhibits, memoranda, or other documentary information in response to the documents submitted on August 13, 1993;

IT IS FURTHER ORDERED, that no later than August 13, 1993, the parties shall identify all witnesses that will be providing testimony in support of the respective party's case; and, that no later than August 27, 1993, the parties shall file a final witness list of all witnesses providing oral testimony, including any rebuttal witnesses; and

IT IS FURTHER ORDERED, that unless there has been a showing of good cause or significant prejudice, a party shall not be allowed at any continued hearing in this proceeding to submit any additional exhibits not previously submitted or present any oral testimony of any witness not previously identified by the dates provided herein.


