Please find this as the Errata to the First Amendment to Petition for District Boundary Amendment filed on May 8, 2013 ("First Amendment").

The purpose of the errata is to correct the tax map key number of the eastern area of the Petition Area. The TMK number stated in the First Amendment and the original petition was (2) 2-2-02: 54 (por.). This, however, was the previous TMK number for the parcel in question. The current TMK number is (2) 2-2-02: 84 (por.).

Consequently, all references to TMK No. (2) 2-2-02: 54 (por.) in all prior filings, including but not limited to the original petition in this docket, the EIS and the First Amendment, and all exhibits attached to the various filings, should be considered replaced with TMK No. (2) 2-2-02: 84 (por.).


Furthermore, we attempted to obtain a current tax map for TMK No. (2) 2-2-02: 84 but was informed by the Maui County Real Property Tax department that they have not yet updated their map for parcel 84. As a result, the current tax map provided in the First Amendment for parcel 54 is the most current tax map available for that land in question.
