ORDER GRANTING PETITIONER'S MOTION FOR ORDER TO RELEASE AND
DELETE CONDITIONS SET FORTH IN THE FINDINGS OF FACT,
CONCLUSIONS OF LAW, AND DECISION AND ORDER DATED JULY 2, 1992

On September 8, 1997, Petitioner St. Francis Medical Center ("Petitioner") filed its Motion For Order To Release And Delete Conditions Set Forth In The Findings Of Facts, Conclusions Of Law, And Decision And Order Dated July 2, 1992 ("Motion") pursuant to Hawai'i Administrative Rules Sections 15-15-70 and 15-15-94.

The Motion requested that the Land Use Commission ("Commission") release and delete all thirteen (13) conditions imposed by the Commission in the subject docket inasmuch as the Petitioner has fully complied with or otherwise reasonably satisfied all of the conditions imposed.

On October 16, 1997, the Office of Planning filed its Response To Petitioner's Motion For Order To Release And Delete Conditions Set Forth In The Findings Of Fact, Conclusions Of Law, And Decision And Order Dated July 2, 1992 ("Response"). The Response represented that the State Department of Defense has

indicated that Condition No. 6 had not been satisfied by the Petitioner.

On October 16, 1997, the Motion came before the Commission at its meeting in Honolulu, Oahu. Action on the Motion was deferred by the Commission in order to allow the parties to resolve the matter of Petitioner's compliance with Condition No. 6.

On October 30, 1997, the continued action on the Motion came before the Commission at its meeting in Honolulu, Oahu.

The Commission, having heard the arguments provided by the parties, both oral and written, and upon review of this entire record herein, and good cause showing therefrom;

HEREBY GRANTS Petitioner's Motion For Order To Release And Delete Conditions Set Forth In The Findings Of Fact, Conclusions Of Law, And Decision And Order Dated July 2, 1992.

IT IS FURTHER ORDERED that Condition Numbers 1 through 13, inclusive, imposed by the Commission in its Findings of Fact, Conclusions of Law, and Decision and Order for LUC Docket No. A92-675 are RELEASED and DELETED.
