On July 30, 1996, the Land Use Commission ("Commission") issued its Order Granting Motion To Continue Hearing And Other Proceedings On Land Use Commission's Order To Show Cause ("Order").

The Order continued the hearing and other proceedings on the Commission's Order to Show Cause in the subject docket for one hundred and twenty (120) days. The continuation of the hearing and other proceedings on the Commission's Order to Show Cause will expire on November 27, 1996.

On November 1, 1996, a Motion To Stay Pending Appeal, filed on September 18, 1996 by First Hawaiian Bank, as Trustee of the Eric A. Knudsen Trust, and Hawaiian Trust Company, Limited, as Trustee of the Augustus F. Knudsen Trust, came before the Commission at its meeting in Honolulu, Oahu. Said motion was subsequently withdrawn by the movant.

The Commission, having considered the arguments presented by the parties and Intervenors, both written and oral, and having reviewed the entire record for the subject docket to date, and with good cause shown;

NOW HEREBY GRANTS a one hundred eighty (180) day extension to the Order Granting Motion To Continue Hearing and Other Proceedings on Land Use Commission's Order to Show Cause from its expiration date of November 27, 1996. The extension to said order shall expire on May 27, 1997.


