Ho'ohana Solar 1, LLC has requested that we submit for the record, RKL's positions regarding the two matters on the A92-683 Agenda regarding the Request to Withdraw Ho'ohana's Motion for Order Bifurcating and Adoption of the Proposed Decision and Order.

With respect to the Request to Withdraw Ho'ohana's Motion for Order Bifurcating -- RKL has no objection.

With respect to Adoption of the Proposed Decision and Order (submitted on December 23, 2014), RKL has no objection to the Proposed Decision and Order. RKL agreed to the Stipulated Conditions at the hearing with the understanding that Canpartners IV Royal Kunia Property LLC is or will be the signatory to the Memorandum of Understanding, and any amendment thereto (collectively the "MOU") with the State of Hawaii Department of Agriculture, and will perform the obligations under the MOU.
