Aloha Randy,

Attached are comment letters we have received so far from various agencies regarding the Glover special permit application. Please respond to all substantive comments, particularly from DEM, USFWS, OP and LUC. You will notice the USFWS is recommending a botanical survey be conducted for the property. Additionally the avoidance periods for various listed species breeding/roosting seasons overlaps, which means Glover would be very limited in when they can quarry the property. USFWS recommends surveys for Hawaiian hawk and Nēnē as well as avoidance measures for the other listed species. The Planning Dept is inclined to require these various surveys prior to taking the application to hearing unless there is some compelling reason we are not aware of as to why these surveys are not warranted.

Please let me know the outcome of your discussion with Scott Derrickson as soon as possible. Give me a call if you have any questions.
