Dear Mr. Orodener:

Pursuant to sections 15-15-42 and 15-15-51, Hawaii Administrative Rules, Piilani Promenade South, LLC and Piilani Promenade North, LLC (collectively "Movants") respectfully request that the hearing on PIILANI PROMENADE SOUTH, LLC AND PIILANI PROMENADE NORTH, LLC'S MOTION FOR ORDER AMENDING THE FINDINGS OF FACT, CONCLUSIONS OF LAW, AND DECISION AND ORDER DATED FEBRUARY 10, 1995 ("Motion"), submitted of even date herewith, be scheduled for no earlier than the second meeting of the Land Use Commission ("the Commission") in August 2014. We also request, and the parties hereby agree, that the date to respond to the Motion be set, at a later time, to follow the hearing at which the Final EIS is presented to the Commission for acceptance, and sufficiently prior to the hearing on the Motion to Amend. We would suggest that the response times and further anticipated filings will be proposed by agreement between the parties, or, if necessary, set by the Commission if agreement cannot be reached.

The reason for this request is that the Movant is in the process of preparing the Environmental Impact Statement, which needs to be accepted and processed by the Commission prior to the hearing on the Motion to Amend. Movant anticipates that the Final EIS will be ready for submission and acceptance by the Commission in mid-summer. I have received agreements from all parties with respect to this schedule; Tom Pierce, on behalf of Movants


