Please find this as the Errata to the Second Supplement to its Motion for Order Amending the Amended Findings of Fact, Conclusions of Law, and Decision and Order Filed October 7, 1996, filed herein on August 13, 2013 ("Second Supplement").

The purpose of the errata is to clarify Canpartners IV Royal Kunia Property LLC's, ("Petitioner") intent and purpose for filing the Second Supplement in regards to proposed modifications to Condition 2 of the 1996 Decision and Order in Petitioner's initial Motion for Order Amending the Amended Findings of Fact, Conclusions of Law, and Decision and Order filed October 1, 1996 in Docket No. A92-683, ("Motion to Amend") on July 15, 2013.
