On April 30, 2009, the Commission held a hearing on an Order to Show Cause as to why the subject property should not be reverted to its former Agricultural designation. On May 20, 2009, the Commission received from Petitioner a Notice of Appearance of the law firm of Bays, Deaver, Lung, Rose & Holma, as co-counsel for Petitioner. On May 21, 2009 the Commission

received from attorneys Nakamoto, Okamoto, & Yamamoto, attorneys for DW Aina Le'a Development, LLC, a petition to be co-petitioner with Bridge Aina Le'a, LLC or in the alternative to be given party status or to intervene. On May 28, 2009, the Commission received from DW Aina Le'a Development, LLC, a motion to stay entry of decision and order on the LUC's action of April 30, 2009.

Following a hearing on these matters on June 5, 2009, and after careful consideration of the arguments made and the records and file in the docket, the following motion was duly made and adopted by a vote of six ayes to one no.

- 1. To take under advisement DW Aina Le'a Development, LLC's motion to be copetitioner or in the alternative to be given party status or to intervene.
 - 2. To stay entry of the Commission's decision and order made April 30, 2009.
- 3. To schedule a hearing limited to one day for receipt of further evidence relative to the Order to Show Cause.
