5. Addressing such other matters as may be deemed appropriate by the Hearings Officer.

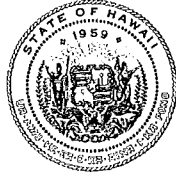
Pre-hearing statements are not required;. Neighbor island parties may participate by telephone by making arrangements in advance with Land Use Commission staff. The
