ORDER GRANTING IN PART AND DENYING IN PART MOTION TO RELEASE CONDITIONS OF APPROVAL DUE TO SATISFACTION OF CONDITIONS

On February 11, 2000, Wailuku Agribusiness Co., Inc. ("Movant"), fka Wailuku Sugar Company, a Hawai'i corporation, successor in interest to Petitioner C. Brewer Properties, Inc., filed a Motion To Release Conditions Of Approval Due To Satisfaction Of Conditions ("Motion"), pursuant to sections 15-15-70 and 15-15-94, Hawai'i Administrative Rules ("HAR"). Movant requested that the Land Use Commission ("Commission") release the conditions of approval imposed in its Order Adopting Hearing Officer's Proposed Findings Of Fact, Conclusions Of Law, And Decision And Order ("Order") dated December 1, 1992, on the basis that all of the conditions have been satisfied.

An Affidavit of Avery B. Chumbley, President of Movant, filed in support of the Motion stated, among other things, that i) all of the conditions of approval have been satisfied; ii) the area redistricted has been in active agricultural production for many years and the Petition For Land Use District Boundary

Amendment was an action to include the cultivated fields within the Agricultural District for continued cultivation; iii) there was no development of the subject property other than agricultural use; and iv) he believed that the continued submitting of annual reports on the status of the subject property was no longer necessary in view of the lack of development of the property and compliance with the conditions as represented to the Commission.

On March 21, 2000, the Office of Planning ("OP") filed a Response To Petitioner's Motion To Release Conditions Of Approval, which agreed to the release of Condition Numbers 1, 2, 6, 7, 8, and 9 and recommended that Condition Numbers 3, 4, and 5 be retained.

The Motion came on for hearing before this Commission on March 23, 2000, in Waikapu, Hawai'i, with appearances by the parties as noted in the minutes. At the hearing, the Commission heard public testimony from Mark Sheehan. The County of Maui Planning Department ("Planning Department") recommended that Condition Numbers 1, 2, 6, 8, and 9 be released and that Condition Numbers 3, 4, 5, and 7 be retained. OP supported the Planning Department's recommendation to retain Condition Number 7. Movant stated that it had no objections to the recommendations of OP and the Planning Department regarding the conditions to be retained. Movant also stated that it had not made any long-term plans for the subject property.

Movant also clarified that it wished to proceed with its motion rather than defer the decision-making to a later date.

Thereafter, a motion was made and seconded that

Conditions Number 2, 8, and 9 be released, but Conditions Numbers

1, 3, 4, 5, 6, and 7 be retained. Following discussion by the

Commissioners, a vote was taken on this motion. There being a

vote tally of 8 ayes, 0 nays and 1 excused, the motion carried.

ORDER

Having duly considered Movant's Motion, the Affidavit in support, the statement made by the public witness, and the oral and written arguments presented by the parties, and a motion having been made at a hearing conducted on March 23, 2000, at Waikapu, Hawai'i, and the motion having received the affirmative votes required by section 15-15-13, HAR, and there being good cause for the motion, the Commission ORDERS as follows:

Conditions Numbers 2, 8, and 9 of the Commission's Order dated December 1, 1992, are released, and Condition Numbers 1, 3, 4, 5, 6, and 7 are retained and continue in effect.

ADOPTION OF ORDER

The undersigned Commissioners, being familiar with the record and the proceedings, hereby adopt and approve the foregoing ORDER this 6th day of April 2000. The ORDER and its ADOPTION shall take effect upon the date this ORDER is certified and filed by the Commission.
