I am a full time resident of Maui. I strongly oppose the proposed Olowalu town development. This would be a disaster for our island-wide ohana and the aina. It would increase exponentially the already severe traffic problems on the route from North Kihei to Lahaina and points beyond.

The land in question sits in the tsunami inundation zone. How can one justify building in such an area, knowing what we now know about rising seas? What insurer would insure the property? I leave aside the question of potential loss of life in case of a major weather event.

The development does not in any significant way address the ongoing crisis in affordable housing here on Maui. It is conceived on the same lines that have given us the upscale ghost towns of Launiauapoko and Wailea.

Worst of all, this development threatens the health and very existence of the best-preserved remaining coral reef on our island. The kupuna coral colonies there—some more than 700 years old—constitute a stockpile of irreplaceable genetic material it is this generation's kuleana to preserve for future generations. Aloha Members of the Land Use Commission,

I, Rosina Potter, live in Haiku, Maui, and oppose the proposed Olowalu town development. The entire development is poorly envisioned and could potentially be a disaster for Maui.

The Olowalu Town plan would boost Olowalu's population from 80 to over 4,000 in the next 10 years, but their inaccurate and incomplete ENVIRONMENTAL IMPACT STATEMENT (EIS) says there will be no impact to:

- Our ocean, reef eco-system, limu, and fish
- Existing roads and traffic
- Our streams and aquifers
- Over-crowded schools
- Loss of prime agricultural land
- Public access to the coastline
- Traditional and customary use of Olowalu lands and waters

Water quality, beach access, and traffic issues aside, primary concern should be focused on the impacts to the near shore Olowalu reef – a 450 acre underwater wonder with over 24 species of coral. Olowalu reef supports one of the state's few black tip reef shark nurseries, and is home to a resident population of nearly 30 manta rays.

Out of all the reef systems on Maui, only *three* areas contain extensive aggregate coral reef (Spreckelsville, Kihei and Olowalu). Aggregate coral reef, mind you, is *not* the typical coral colonies you see growing on lava, but is instead thick reef structure. One lobe coral colony on the reef is so large that scientists estimate it to be about 500 years old. The area is also home to several species of rare corals, and has the highest diversity of Porites species and growth forms in the entire island chain.

The proposed Olowalu Town development threatens to significantly alter the entire area, both underwater and on land.

The estimated traffic impact is a joke. These numbers have been successfully contested in their previous applications. Traffic to Lahaina is already unbearable and there are thousands of homes already in the pipeline to be built in West Maui. Re-alignment of the highway through an endangered bird nesting area (the nene) is not a viable solution.

The area is in a tsunami inundation zone.

There are wildfires nearly every year.

The majority of the homes will not be affordable to the average local families here on Maui, and by their own admission, those numbers will not be available for some

time.

The proposed Olowalu development will potentially become a ghost town of vacation rentals like Launiupoko and Wailea.

It is shocking to see the proposed change in zoning to "hotel" around the historic Olowalu wharf area that holds various structures of historical significance.

In the applicant's own words on page 28 of Part 1 of their FEIS, "Olowalu Valley is a pu'uhonua, or sanctuary, which existed from prehistoric time for anyone fleeing oppression....Violating pu'uhonua sanctuary was punishable by death."

It is a mockery of the Hawaiian culture to then list false promises (that are currently unenforceable) to slither themselves around their violation of a pu'uhonua.

I ask you to stand with us and reject the Olowalu town development for the sake of future generations, a healthy thriving coral reef ecosystem, and protecting one of the most beautiful open spaces on Maui.

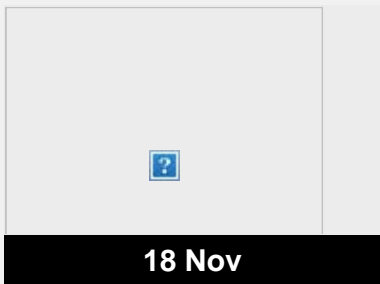
