PREHEARING ORDER

WHEREAS, it is desired to expedite the orderly conduct and disposition of this proceeding by a prompt and timely exchange of witness lists, exhibit lists, and exhibits;

WHEREAS, an e-mail notice of a Stipulated Agreement among the Parties in this proceeding was received on January 13, 2017, to identify the positions of the respective parties; to identify and clarify issues; to arrange for the timely submission of witness lists, exhibit lists, and exhibits; and to set schedules; now, therefore,

IT IS HEREBY ORDERED that (1) no later than the close of business on February 22, 2017, each party shall submit and serve upon all the other parties a final witness list identifying all witnesses that will be providing testimony in support of the respective party's position, a final exhibit list identifying all exhibits that will be submitted in support of the respective party's position, and all exhibits identified in the aforementioned exhibit list, with the exception of the written direct testimony of their respective expert witnesses; and (2) no later than the close of business on March 3, 2017, a party shall submit and serve upon all the other parties any exhibits, memoranda, or other documentary information in response or in rebuttal to the documents submitted on February 22, 2017, provided that each party no later than the close of business on March 3, 2017, shall also submit and serve upon all the other parties as appropriate a rebuttal witness list, a rebuttal exhibit list, all rebuttal exhibits, and the written direct testimony of their respective expert witnesses identified in the aforementioned witness list;<sup>1</sup>

IT IS FURTHER ORDERED that unless there has been a showing of good cause or the lack of significant prejudice, filings or submissions which are



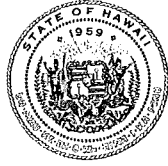
untimely may be stricken or rejected by the Land Use Commission
