On September 1, 2016, Petitioner filed written direct testimony for Tom Nance, Allan Schildknecht, and Bruce Plasch, Ph.D. Petitioner gave notice that these experts were in the process of gathering information and conducting tests. Petitioner described the subject matter of these experts' work product and gave notice that supplemental written direct testimony would be provided as soon as it is available.

Petitioner's experts are continuing their analyses and are not able to present their conclusions at this time. The purpose of this supplemental written testimony is to provide an update and additional information.


Currently, Tom Nance has conducted an extended pump test of Well 1. Mr. Nance will testify about the outcome of this test and is exploring additional tests that may be relevant.

Allan Schildknecht has compiled information regarding irrigation practices at the Manele golf course and at golf courses throughout the State of Hawaii. He expects to finalize his findings in the coming weeks.

Bruce Plasch, Ph.D. has compiled economic information from Petitioner and other sources and is currently conducting his analysis. He expects to finalize his findings in the coming weeks.

Petitioner will provide supplemental written direct testimony summarizing the experts' analyses and findings as soon as they are available, and all three experts will provide testimony about their methods and conclusions at the hearing.


