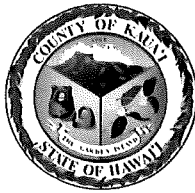



6. That Affiant makes this Affidavit in compliance with § 15-15-97(k)(3), Hawai'i Administrative Rules.

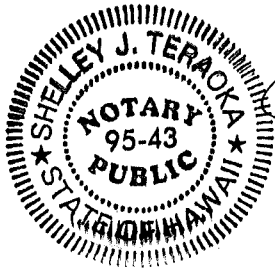

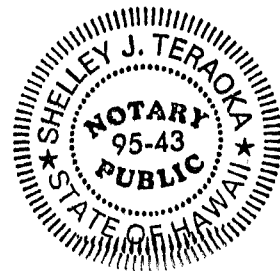
