NOTICE OF IMPOSITION OF CONDITIONS BY THE LAND USE COMMISSION

KNOW ALL PERSONS BY THESE PRESENTS:

Please take notice that the County of Kaua'i, by and through its Housing Agency ("Petitioner"), was the Petitioner in the State Land Use Commission ("Commission") Docket No. A17-802 for reclassification of approximately 75 acres of land situated in 'Ele'ele, Kaua'i, Hawai'i, more particularly identified as Tax Map Key No. (4) 2-1-001:054 ("Petition Area"), and does hereby state and declare that the Commission, by its Decision and Order dated July 24, 2017, reclassified approximately 75 acres of the Petition Area under Docket No. A17-802 from the State Land Use Agricultural District to the State Land Use Urban District (hereinafter "Property"), subject to a number of conditions imposed on the reclassified Property. Said conditions shall run with the land and shall be set forth in the Declaration of Conditions to be subsequently recorded in the Bureau of Conveyances of the State of Hawai'i pursuant to Section 15-15-92, Hawai'i Administrative Rules.

This Notice of Imposition of Conditions by the Commission shall be superseded upon the recordation at the Bureau of Conveyances of the said Declaration of Conditions setting forth the conditions imposed by the Commission in Docket No. A17-802.

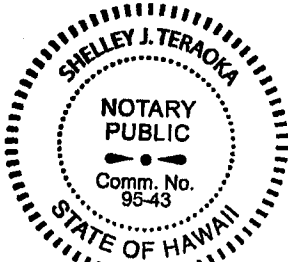

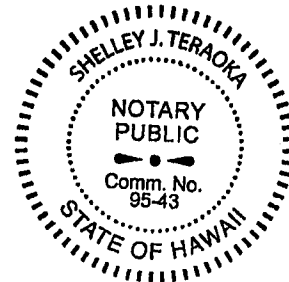
