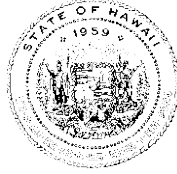

The Land Use Commission (LUC) will convene on Kaua`i on July 19, 2017 to consider the adoption of order relating to the above-referenced docket. In keeping with LUC practice, the public will be afforded the opportunity to provide public testimony on the agenda item.

However, in order to ensure that all parties have had the opportunity to present their arguments and in recognition of the fact that the proceedings on July 7, 2017 were cut short due to time constraints, the LUC will allow the parties an additional 15 minutes to present closing arguments. Prior to receiving public testimony from the public and because the LUC was not able to hear closing argument from the parties on July 7, 2017 due to travel issues, the LUC will entertain argument from all parties at the July 19<sup>th</sup> meeting. The parties will be given the opportunity to present argument before the LUC votes on the adoption of the order, and are free to address any issue relating to the evidence presented during the evidentiary hearing, including comments and recommendations on the Petitioner's proposed decision and order.
