
INTERVENOR COLLEEN HANABUSA'S: (1) POSITION STATEMENT  
ON INTERVENORS KO OLINA COMMUNITY ASSOCIATION AND  
MAILE SHIMABUKURO'S MOTION TO REOPEN THE CONTESTED  
CASE HEARING TO ADMIT LIMITED ADDITIONAL DOCUMENTARY  
EVIDENCE TO CORRECT AN ERROR THAT WAS DISCOVERED  
AFTER THE HEARING CLOSED, FILED ON APRIL 27, 2012; AND (2) STATEMENT  
OF NON-APPEARANCE AT THE HEARING ON THE SAID MOTION

COMES NOW Intervenor COLLEEN HANABUSA, by and through her counsel undersigned, and hereby submits her position on the Intervenor Ko Olina Community Association and Maile Shimabukuro's Motion to Reopen the Contested Case Hearing to Admit Limited Additional Documentary Evidence to Correct an Error that was Discovered after the Hearing Closed, Filed on April 27, 2012.

On August 17, 2016, at the hearing before the Planning Commission on Intervenor Ko Olina Community Association and Maile Shimabukuro's Motion to Effect the Consolidation of the Separate Proceedings in 2008 SUP-2 as Ordered by the State Land Use Commission on October 8, 2012, filed on January 15, 2013, Intervenor Colleen Hanabusa raised her objections on the motion to consolidate the records of the two proceedings. Over the Intervenor Colleen Hanabusa's objections, the Planning Commission granted the said motion. Now that the two records have been consolidated, and without waiving her objections on the consolidation of the two records, Intervenor Hanabusa believes that the requested correction by Intervenor Ko Olina Community Association and Maile Shimabukuro is appropriate and should be allowed.

Also, on August 17, 2016, counsel informed the Chair that he would not be available on October 12, 2016 for a hearing. Counsel will be out-of-state and not available to attend the hearing and, as a result, Intervenor Hanabusa submits this statement of non-appearance at the hearing on October 12, 2016.


