Projects include work with the Ulupono Initiative on their 5 year strategic plan update on food self sufficiency; The Kohala Center on the State's pilot Farm to School initiative in North Kohala and assorted assignments from the chair of the Department of Agriculture on statewide Food Metrics to track the increase in local food production to meet the governor's goals and to dovetail with the work of the broader Hawaii Green Growth Initiative.

# 2014-2016 Research Corporation of Hawaii: Statewide Agricultural Land Use Baseline

Served as instigator and Project Manager for the production of a new statewide agricultural land use baseline. The project was funded by the State Department of Agriculture to document the current foot print of agriculture statewide as a tool to provoke informed discussion on how to address current challenges in the industry. The resulting digital data and accompanying report provide a current look at the status of crop and pasture use in the state and discusses the changes over time. Project involved extensive travel and interviews with farmers and land managers statewide and the supervision of digital mapping and exhibit creation. The project was done in close collaboration with the DOA Director and involved several dozen presentations statewide to industry groups; government agencies and university audiences to provoke informed discussion on the current challenges and opportunities in local agriculture.

# 2012-1014 County of Hawai'i Special Projects Officer Office of the Mayor, and Dept of Research and Development

This was a contractual position with the County of Hawaii responsible for managing a range of projects for the Office of the Mayor and the Department of Research and Development. Projects included a very successful Joint Fact Finding process to address community concerns related to the potential impacts of geothermal energy production on public health in the Puna community. This process lead to a consensus approach to the development of a major public health study to investigate a specific set of concerns associated with exposure to H2S, and series of other environmental studies.

Assignments with Research and Development involved initiating programs to increase food self reliance in Hawaii County. It also involved the management of the County's agricultural initiatives including the preparation and management of nearly 20 contracts with local community programs, and research organization. I was also responsible for organizing forums that drew together farmers and public support agencies to improve services and a session involving new farmer training practitioners statewide to identify shared lessons and opportunities.

#### 2014- Accord 3.0 Network Associate

The Accord 3.0 Network is made up of roughly 25 seasoned and respected professionals from Hawaii, the US and the Asia Pacific basin who collaborate on alternative approaches to address complex public policy issues, environmental disputes and scientific uncertainty. Accord 3.0 brings together multi-disciplinary teams to address complex issues, conduct joint fact finding initiatives, trainings, workshop and consultative engagements to assist communities, agencies and businesses to address difficult issues and improve public policy decision making.

Projects related to Accord 3.0 that I have been involved in include implementation of recommendations from a joint fact finding initiative on health concerns associated with geothermal energy development in Puna; and several efforts related to Hawaii's local food production and the development of metrics to help measure local food self-reliance on a statewide basis.
