1. That Affiant is the Housing Director of the County of Kaua'i Housing Agency (the "*Housing Agency*"), a political subdivision of the State of Hawai'i.
2. That the Housing Agency is the Petitioner for a State of Hawai'i Land Use District Boundary Amendment in Docket No. A17-802, to amend the land use district classifications of certain lands situate at 'Ele'ele, Kaua'i, Hawai'i; consisting of approximately 75 acres, and identified as Tax Map Key No. (4) 2-1-001:054, from the Agricultural Land Use District to the Urban Land Use District.
3. That the Housing Agency held public information meetings as part of its pre-draft environmental assessment consultations on September 28, 2011 at Hanapēpē Public Library; February 22, 2012 at Hanapēpē Public Library; August 24, 2015 at the 'Ele'ele Elementary

4. That the Housing Agency held public consultation meetings to review the draft environmental assessment and as part of the HRS Chapter 201H Application process on May 24, 2016 at Hanapēpē Public Library and on May 25, 2016 at the 'Ele'ele Elementary School Cafeteria.

5. That the Housing Agency solicited and received written comments from interested Federal, State, and County agencies in 2016.

6. That Affiant makes this Affidavit in compliance with § 15-15-97(k)(3), Hawai'i Administrative Rules.

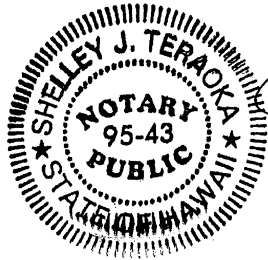

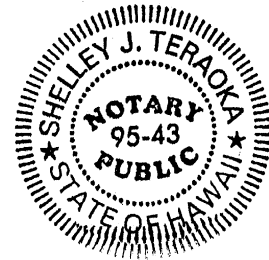
