To delete Condition No. 14 of Special

“14. Municipal solid waste shall be allowed at the WGS� up to July 31, 2012, provided that only ash and residue from H-POWER shall be allowed at the WGS� after July 31, 2012.”


**STIPULATION AND ORDER TO CONTINUE  
THE FEBRUARY 20, 2013 HEARING TO APRIL 10, 2013**

The Honolulu Planning Commission (“Commission”) has scheduled a hearing in this matter for February 20, 2013 at 1:30 p.m. for consideration of and action on (1) the State Land Use Commission’s October 8, 2012 Order Remanding County Special Use Permit File No. 2008/SUP-2 to the City and County of Honolulu Planning Commission (Docket No. SP09-403); and (2) Intervenor Ko Olina Community Association and Maile Shimabukuro’s (together “KOCA”) Motion to Effect the Consolidation of the Separate Proceedings in 2008 SUP-2 as Ordered by the State Land Use Commission on October 8, 2012.

Applicant Department of Environmental Services, City and County of Honolulu, and KOCA are currently in discussions regarding the above-referenced proceedings. Under the circumstances, the parties to this proceeding request that the Commission continue the hearing on both (1) and (2) as noted above that are currently scheduled for February 20, 2013 to April 10, 2013 or as soon thereafter as counsel may be heard.






