As requested, this letter provides independent notification of the information previously reported in the semi-annual Report dated August 30, 2011.

As reported, in early August 2011, Waste Management of Hawali, Inc. (WMH) Identified suspect readings from recent wellhead monitoring and undertook an investigation. On August 26, 2011, the WMH employee admitted that he had falled to take numerous wellhead readings and instead fabricated those readings. WMH has terminated that employee and is undertaking further investigation to determine the scope of noncompliance. Therefore, the values reported for the 6-month average and maximum gauge pressures, oxygen concentrations, and temperatures are based on only the values for those wells and sampling events that were actually measured. The semiannual report does not include data that WMH reasonably suspects or has confirmed is not actual data taken for the wells.

Following completion of our investigation, a copy of our findings will be shared with your office. If you have additional questions please contact me at 808-668-2985.

issued a Notice of Violation ("NOV") concerning the MSW release. EPA did not impose any penalties as part of the NOV and continues to monitor the WGSL operations closely.

- 3. Irregular Landfill Gas Data.
- 82. In September 2011, WMH notified the City, EPA, and DOH that it identified significant irregularities with the landfill gas data that had purportedly been collected and recorded by its landfill gas technician at WGSL. Further investigation by WMH revealed that a rogue WMH employee had fabricated some wellhead gas parameter measurements instead of collecting the data through verifiable measurements. The employee failed to collect actual data from mid-2010 until August 2011.
- As a result of WMH's initial investigation, WMH hired an environmental consultant to perform a detailed assessment of (1) the current status of the wellfield and gas collection and control system to determine whether the fabricated data has concealed adverse changes in the wellfield, and (2) the past status of the wellfield based on verifiable data. Based upon the detailed assessment, WMH concluded that the wellfiled and gas collection control system is performing within the expected range of monitored parameters at the facility and that there is no evidence that the wellfield has undergone any adverse changes in the last two years.

V. WGSL IS NECESSARY FOR PROPER MANAGEMENT OF MUNICIPAL SOLID WASTE

84. The 2009 Planning Commission did not place an expiration date on 2008/SUP-2 or any deadline for the acceptance of waste at WGSL because it recognized the futility of setting unrealistic deadlines for closure. As Planning Commissioner Komatsubara stated, "[S]imply putting on a new closure date to this new SUP will not lead to the closure of the Waimanalo Gulch Sanitary Landfill. . . . [T]he focus should not be on picking a date. The focus should be on how do we get the City to select a new site because you're not going to close this landfill until

- By 2012, when HPOWER's third boiler is expected to be fully operational, the City anticipates that about eighty percent (80%) of the island's waste stream will be diverted from landfill disposal. See 2009 Planning Commission Decision, ¶ 101, pg. 20. Twenty percent (20%), however, of O'ahu's waste will still need to be landfilled at WGSL, as certain wastes cannot be recycled or combusted. Id., see also ¶¶ 92, 97, pgs. 18-19. Further, the expanded HPOWER facility will still require the continued availability of WGSL as a permit condition to operate, to ensure proper disposal of MSW that is diverted from HPOWER due to routine maintenance, unanticipated closures or if the amount of waste exceeds the capacity of the facility.
- 90. A landfill is currently necessary for proper solid waste management to avoid the potential health and safety issues for O'ahu's residents and visitors. Accordingly, because WGSL is the only currently permitted landfill available to serve O'ahu's municipal solid waste needs, it is also the City's best and only viable option for disposal of certain wastes. Requiring the landfill to stop accepting MSW on July 31, 2012, will have immediate and dire consequences for all of O'ahu.

Waste Management responds as follows:

I. Intervenors Already Have Most of the Discoverable Documents That are Described in the Subpoena

Waste Management represents that for the most part the requested documents, as identified below, are already in the possession of the Intervenors and other parties in the pending

proceeding involving the Application filed on June 28, 2011 by the DEPARTMENT OF ENVIRONMENTAL SERVICES, CITY AND COUNTY OF HONOLULU ("ENV").

- 1. The Subpoena seeks documents and information that the Intervenors already have in their possession as evidenced by the Exhibit Lists submitted by Intervenors, and the following identified Exhibits and/or are more readily obtainable from sources other than Waste Management, including, but not limited to, the Applicant ENV.
- 2. Specifically, the Intervenors currently possess the relevant, pertinent, non-confidential, non-privileged information relating to the wellhead monitoring readings at the Waimanalo Gulch Sanitary Landfill taken in 2010 and 2011 as requested in the Subpoena, as identified in items 3 6 below:
- 3. EIL 2009 through 2011 Waimanalo Gulch Sanitary Landfill, Monthly Perimeter Gas Monitoring Letter Reports prepared for Waste Management which Dwight Miller of Parametrix relied on as a reference in preparing Intervenors' Exhibit 146.
- 4. Intervenors Exhibit K-157 listed in Intervenors' December 20, 2011 Second Amended Exhibit List, the wellhead monitoring issue is described and explained in the August 30, 2011 letter from Timothy E. Steinberger, Director of Applicant ENV to Ronald Ho of the Clean Air Branch, Department of Health, State of Hawaii and John Brock of the EPA and the attached August 29, 2011 Semi-Annual Report January 1, 2011 through June 30, 2011 prepared by Environmental Information Logistics ("EIL") relating to Waimanalo Gulch Sanitary Landfill, Covered Source Permit No. 0489-01-C.
- 5. Intervenors Exhibit K-158 listed in Intervenors' December 20, 2011 Second Amended Exhibit List, the wellhead monitoring issue is further described and explained in the August 18 [sic], 2011 letter from Justin Lottig, Environmental protection Manager of Waste

Management to John Brock of the EPA and Ronald Ho of the Clean Air Branch, Department of Health, State of Hawaii. Note that Intervenors Exhibit K-158 refers to the Semi-Annual Report dated August 30, 2011 and was actually submitted on September 2, 2011. Waste Management represents that the date of Intervenors Exhibit K-158 should be September 2, 2011.

6. Intervenors Exhibit K-160 listed in Intervenors' January 5, 2012 Third Amended Exhibit List, the September 28 2011 Landfill Gas Extraction Assessment prepared by EIL relating to relating to Waimanalo Gulch Sanitary Landfill. This Assessment was undertaken to investigate the fabricated wellhead monitoring readings which is the subject of the Subpoena. Significantly, the conclusion states, in part, as follows:

There is no evidence of adverse changes in the condition of the wellfield. In particular, there is no evidence of any SOE [subsurface oxidation event], no smoke, no odor, no localized subsidence adjacent to any well. Therefore, despite the absence of some data during the time period in question, the available data shows no wild swings and no adverse changes in the condition of the wellfield. In particular, there is no evidence of an SOE or even conditions that would present a risk of an SOE. Further, the data indicates, even if the manual data was included in any evaluation, it would not significantly alter any of the conclusions or materially skew the data.

Intervenors Exhibit K-160 at 32. [Bracketed material added]

7. In response to the Subpoena, Waste Management submits attached Exhibit 1, which is the October 3, 2011 letter of Joseph R. Whelan General Manager of Waste Management sent to Timothy Steinberger, Director of Applicant ENV relating to the Landfill Gas Management System Investigation Report and which transmitted Intervenors Exhibit K-160.

- 8. In response to the Subpoena, Waste Management represents that it is not aware of any government notices, citations, and/or orders related to the fabricated readings.
- 9. In response to the Subpoena, Waste Management represents it is not aware of any other correspondence with the City and County of Honolulu and/or any other governmental agency or body related to the fabricated readings.
- 10. In response to the Subpoena, Waste Management submits attached Exhibit 1, which describes the remedial actions taken to address the fabricated readings.

II. Waste Management of Hawaii Objects to the Subpoena to the Extent It Seeks Irrelevant and Privileged Documents

Waste Management objects to the Subpoena on the following grounds:

- 1. The Subpoena seeks documents that are protected by the attorney-client privilege and/or work product doctrine.
- 2. The Subpoena seeks documents that contain highly confidential and proprietary, commercial and other highly sensitive business information.
- 3. The Subpoena is vague, overly broad, and seeks documents that are neither relevant to the subject matter of this action nor reasonably calculated to lead to the discovery of relevant information.
- 4. The wellhead monitoring readings are irrelevant to the sole issue in this proceeding -- whether to delete Condition No. 14 of Special Use Permit No. 2008/SUP-2, which provides that municipal solid waste shall be allowed at the Waimanalo Gulch Sanitary Landfill up to July 31, 2012.
- 5. In seeking the documents described in the Subpoena, the Intervenors impermissibly seek to broaden the scope of and unduly delay this proceeding.

- 6. The Subpoena is oppressive and unduly burdensome in scope because it is vague, overly broad, and seeks documents that are privileged and/or are neither relevant to the subject matter of this Planning Commission proceeding, nor reasonably calculated to lead to the discovery of relevant information and has resulted in undue time and expense to Waste Management in responding to the Subpoena.
- 7. For these reasons, Waste Management respectfully objects to any further production of documents described in the Subpoena.

Dear Mr. Steinberger:

As you know, in August, Waste Management of Hawaii, Inc. (WMH) discovered and reported that a large amount of landfill gas data that had purportedly been collected and reported to us by our former landfill gas technician had not in fact been collected. Instead, the data had been fabricated and manually entered into Waste Management's Landfill Gas Management System (LGMS). Based on Interviews conducted during the investigation, we learned that the failure to collect data and the fabrication of replacement data began in mid-2010 and continued until August 2011 when the failure was investigated and identified. The failure to collect data and the manual entry of fabricated data into LGMS database is a clear violation of the company's written policy and procedures.

WMH deeply regrets the failure of this one employee to do his job and the unfortunate damage it caused to the credibility of the rest of WMH's hardworking landfill staff. We have implemented a number of procedures to prevent any future recurrences of this problem. First, the landfill gas technician no longer works for WMH and we are actively seeking to hire another technician. Second, we have modified our LGMS program to allow users to easily determine whether records are uploaded directly from a monitoring instrument or are manually entered. Third, we have placed restrictions on the ability of the "Technician" level gas technicians to enter data manually as follows:

- ➤ Wells: Manual entry of primary composition and physical parameters normally measured by the GEM monitoring instrument will not be allowed by users with "Technician" level access. These users will retain the ability to manually enter comments and other gas concentrations not normally measured with a gas emissions monitor (GEM) instrument.
- ▶ Probes: Manual entry of primary composition and physical parameters normally measured by the GEM will no longer be allowed by users with "Technician" level access. These users will retain the ability to manually enter comments and other gas concentrations not normally measured with a GEM instrument.
- > Sample Ports: Manual entry of primary composition and energy parameters normally measured by the GEM will no longer be allowed by users with "Technician" level access. These users will retain the ability to manually enter physical parameters, comments, and other gas concentrations.

Kapolei, Hl 96707 (808) 668-2985 (808) 668-1366 Fax Not only has WMH implemented these changes for the Waimanalo Gulch Landfill, Waste Management has implemented these changes throughout the entire company for all of its landfills (over 200 landfills). These changes became effective on September 29th.

As a result of the discovery of the fabricated data, WMH also asked its third-party consultant, Environmental Information Logistics, LLC (EIL), to conduct a detailed assessment of (1) the current status of the wellfield and the gas collection and control system (GCCS), and (2) the past status of the wellfield based on data that conservatively excludes all data that was manually entered into LGMS. The purpose of this assessment was to provide reassurance that the fabricated or suspect data had not concealed adverse changes in the wellfield.

I am attaching a copy of ElL's report – *Landfill Gas Extraction Assessment* (Sep. 28, 2011) – which confirms the following:

- Based on the most recent verified data, there have been no adverse impacts on the wellfield, and the wellfield is acting consistent with WMH's expectations.
- While some gas temperatures have risen over the period in some wells, temperatures have not
 exceeded expected levels based on the wells' proximity to other wells with similar temperatures
 and can be explained by changes in fill elevations.
- Carbon monoxide concentrations are historically consistent and do not indicate any condition considered abnormal at the facility.
- Despite the absence of some data during the period in question, the available data shows no large variations and no adverse changes in the condition of the wellfield. Further, the data indicates, even if the manually uploaded data were included in the evaluation, it would not significantly alter any of the conclusions or materially skew the overall monitoring data.

We will continue to review the data from the well field to ensure that it continues to fall within expected and normal operating conditions.

eWaste (Electronic Waste)

What to do with your old electronics

The rules are different for home versus business and government e-waste. Business and governmental e-waste is banned from disposal on Oahu. Home electronics are exempted from the ban and can be disposed of with regular household refuse or bulky collection, but you are encouraged to consider the recycling options presented below. More recycling programs and options are evolving locally and nationwide each year.

Locally, the Hawaii Electronic Waste and Television Recycling and Recovery Law was adopted by the Hawaii State Legislature in 2008. It requires electronics manufacturers to provide recycling programs for computers, computer monitors and televisions. The State Department of Health is responsible for implementing this new law.

On Oahu, e-waste was banned from disposal as of July 2006. Household and small quantity generators are exempt in accordance with EPA guidelines. Local businesses or commercial entities, which generate e-waste should contact the state Department of Health - Solid and Hazardous Waste Branch for more information, or refer to an e-waste recycler (eCycler) listed below.

All types of generators -- commercial, government, household -- are encouraged to investigate reuse options offered by local non-profits and trade-in programs offered by manufacturers.

Donate

Donate computer equipment to local schools and organizations. Newer, working equipment is preferred, however older or non-working equipment may also be accepted.

Hawaiian Hope

Hawaiian Hope accepts PC-compatible computer equipment (no Apple Mac products). CPU Units (the main box) can be repaired if not working, but all components (printers, monitors, mice, etc,) must be in WORKING condition. Hawaiian Hope will accept computers as old as 1Ghz Pentium 4, individual parts such as mice, memory, video cards, and network cards. Hawaiian Hope is especially in need of network switches (not hubs), networking hardware, cables, speakers and hard drives -- 20 GB and up and (They will scrub them clean for you while you watch.). Hawaiian Hope is also always looking for volunteers.



Batteries



Give your old auto batteries to the dealer when purchasing new ones, as State law requires the dealer to accept and recycle them. Householders may also take them to any City Convenience Center. Drop off rechargeable batteries from cell phones, computers and power equipment at Home Depot, Best Buy and Radio Shack as part of the national RBRC program. Regular alkaline (non-rechargeable) batteries can be safely disposed of with your regular refuse collection. Manufacturers no longer use heavy metals in their production.

Hawaii Electronic Waste and Television Recycling and Recovery Law

Consumer Information

Manufacturers of covered electronic devices (CEDs) and televisions sold in the state of Hawaii must provide recycling options for these devices. Information on CED and television recycling programs will be made available by manufacturers, retailers and the Department of Health (DOH).

Electronic Devices

Electronic devices covered under this law include:

- Computers
- Computer printers
- Computer monitors; and
- Portable computers with screen size greater than four inches measured diagonally.

Televisions

Televisions covered under this law include devices that are capable of receiving broadcast, cable, or satellite signals and displaying television or video programming. Including, without limitation, any direct view or projection televisions with viewable screen sizes of nine inches or larger with display technology based on cathode ray tube, plasma, liquid crystal on silicon, silicon crystal reflective display, light emitting diode, or similar technology.

Timeline

January 1, 2010

Consumers may begin to recycle their CED through the manufacturer recycling programs.

Retailers shall make information available to their customers about recycling services offered by CED manufacturers.

Unlabeled CEDs prohibited from sales.

CED brands for sale must be registered with DOH.

January 1, 2011

Consumers may begin to recycle their TVs through the manufacturer recycling programs.

Retailers shall make information available to their customers about recycling services offered by TV manufacturers.

Unlabeled TVs prohibited from sales.

TV brands for sale must be registered with DOH.

Manufacturer Recycling and Recovery Plans

Manufacturers are required to implement recycling plans for CEDs and TVs sold in Hawaii. Recycling plans are subject to the following conditions in law:

- No fee shall be charged at the point of recycling if the CED/TV is brought by the owner
 of the device to a central location for recycling.
- A reasonable transportation fee may be charged if the CED/TV manufacturer or manufacturer's agent removes the CED/TV from the owner's premises at the owner's request and if the removal is not in conjunction with delivery of a new CED/TV to the owner.
- Each manufacturer may develop its own recycling program or may collaborate with other manufacturers.

CED manufacturers shall implement and fully operate their recycling plans no later than January 1, 2010. TV manufacturers must implement plans no later than January 1, 2011.

anticipated as the amount of water required for operation will exceed the amount stored. Supplemental water from the on-site well will make up the balance. As a result of storm water remaining on-site, HER will be requesting an exemption from requiring a NPDES for Storm Water Associated with Industrial Activities.

2.4 Project Schedule and Cost

Construction of the project is planned to commence once this environmental document is completed and other environmental clearances and permits obtained. Construction of the proposed project is anticipated to take approximately one year. The facility will be in operation by the end of early 2013 to accept 100,000 tons of green waste, food waste and dewatered sewage sludge annually. And The facility will be capable to accept up to 150,000 tons annually. The estimated construction cost is \$40 million.

6.0 CONTEXTUAL ISSUES

6.1 Relationship Between Local and Short-Term Uses of Humanity's Environment and the Maintenance of Long-Term Productivity

6.1.1 Short-Term Effects

Short-term uses and long-term productivity consist of the project's short-term construction phases and long-term benefits of the project after construction.

During construction, there will be short-term uses involving temporary and permanent alteration of the land for grading, site work and excavation for building foundations, concrete pads for windrow system and utilities. Short-term construction impacts can be avoided or mitigated by implementation of best management practices (BMPs). BMPs may include construction of berms to detain run-off and installation of silt fences to filter silt from run-off.

In the short-term, the propose project alternatives will also confer some positive economic benefits in the local area. Direct economic benefits will result from construction expenditures both through the purchase of materials from local suppliers and through the employment of local labor. Indirect economic impacts may include benefits to local retail businesses resulting from construction activities.

6.1.2 Long-Term Effects

In the long-term, the proposed project will have beneficial impacts on the environment by composting up to 150,000 tons per year of green waste, food waste and dewatered sewer sludge. By recycling and reusing organic materials, this waste is being turned into a beneficial product, such as compost, soil amendments, potting mixes, fertilizer replacement/enhancement, gardening and landscaping products. This Project will be an important and integral component of Oahu's overall Solid Waste Management System, as private companies, such as HEP, assist the City and County of Honolulu's efforts to direct materials for reuse. Use of product will also reduce reliance on imported fertilizers and soil amendments. Without this composting facility, approximately 5,000 to 10,000 tons per year of food waste and 15,000 to 20,000 tons per year of sewage sludge would continue to be placed in Oahu's only landfill with no other alternatives. Also, in the long-term, while the project initially will likely relocate workers from the existing operation at Campbell Industrial Park, the expanded facilities will create additional job opportunities.

6.2 Cumulative Impacts

Cumulative impacts are those that result from the incremental impact of the action when added to other past, present and reasonably foreseeable future actions. Together with other existing and anticipated future development in the area, the project has the potential to generate cumulative impacts, including slight increases in overall traffic volumes on regional transportation facilities, operational and irrigation water demand,

The 80 percent discount on "lipping fees" charged by the city when companies deliver recycling residue to the Waimanalo Gulch landfill cost the city about \$2 million last

It has been criticized by some as too generous to a single company: Schnitzer Steel Hawaii, which does the most recycling in Honolulu with more than 100,000 lons of metal a year from automobiles, appliances and other bulky metal items. Since 1998 Schnitzer has received about \$19 million in discounts, including \$1.9 million last year.

While lawmakers have said they want to do away with the subsidy in the interest of fairness they also have said they want to continue to encourage recycling. They continue to work on proposals that would restore the subsidy at a lower rate and cap the amount a single company could claim.
