hereby files its written status report for January 2018 pursuant to the Land Use Commission of the State of Hawaii Order Requiring Written Status Reports, dated May 28, 2014.

As reported in the prior written status report, on November 22, 2017, Intervenor Ko Olina Community Association and Maile Shimabukuro filed a Motion to Reopen the Contested Case Hearing (“Motion to Reopen”). On December 2, 2017, ENV filed a Memorandum in Opposition to the Motion to Reopen. To date, the Honolulu Planning Commission (“Planning Commission”) has not taken action on the Motion to Reopen.

At a meeting on December 6, 2017, the Planning Commission adopted its proposed Findings of Fact, Conclusions of Law, and Decision and Order. The Planning Commission set a schedule for the parties to submit written exceptions and present oral argument, as required by §2-75 of the Rules of the Planning Commission. Written exceptions are due February 5, 2018, and the parties will present oral argument on March 7, 2018.
