A98-725 - A & B PROPERTIES, INC. (Spreckelsville, Maui)

Pursuant to a notice published in the Honolulu Advertiser and the Maui News and notices sent to all parties, a hearing was called by the Land Use Commission in the matter of the petition by A & B Properties, Inc. to consider reclassifying approximately 212 acres of land currently in the Agricultural District into the Urban District at Spreckelsville, Wailuku, Maui for residential units, 9-hole golf course and park.

Commissioner Kelai was excused from this proceeding due to a conflict of interest.

Disclosures were made by Commissioner Catalani and Commissioner Desai. There were no objections by the parties to have Commissioner Catalani and Commissioner Desai participate in the proceedings.
