Deputy Attorney General Jon Itomura presented a summary of the proposed amendments to the Land Use Commission Rules and Regulations.

Commissioner Kaopua moved to authorize staff to proceed with public hearings on the proposed amendments to Chapter 15 of Title 15, Hawaii Administrative Rules of the Land Use Commission. The motion was seconded by Commissioner Chun and unanimously approved by voice votes.

MISCELLANEOUS

- 1. Executive Officer Esther Ueda updated the Commission regarding A92-684/Department of Transportation. The motion to Circuit Court to allow DOT to come back to the Land Use Commission to finish their contested case hearing was continued until late December. The Executive Officer will keep the Commission apprised of the outcome of that hearing.
- 2. A status report on litigation matters on the following dockets was given by Deputy Attorney Jon Itomura: DR97-20 Pono, et al. (Molokai). He reported that arguments were moved to December 11, 1998; A93-701/Kaupulehu Developments request for oral arguments was denied by the Supreme Court; A89-649/Lanai Resort no movement, no word from Judge Raffetto.
- 3. The Executive Officer announced that a response was sent to Alan Murakami's letter of September 4, 1998 requesting that the Commission move forward with the Motion To Revert Property To Its Former Classification ("Motion to Revert") filed by Intervenor Lanaians For Sensible Growth. According to Jon, the Commission cannot continue with the Motion to Revert until
