# A98-724 - STANFORD S. CARR DEVELOPMENT CORPORATION

Chairperson Kelai announced that the Commission would take action to consider reclassifying approximately 24.267 acres of land currently in the Agricultural District into the Urban District at Wailuku, Maui for a single-family residential subdivision and a park site.

Commissioner Jarman voiced concerns regarding the language of condition one pertaining to the affordable housing condition. She preferred the language to include the Commission's standard language which is highlighted below:

"1. Petitioner shall provide affordable housing opportunities for low, low-moderate, and gap group income residents of the State of Hawai'i to the

satisfaction of the County of Maui. The County of Maui shall consult with the State Housing and Community Development Corporation of Hawai'i prior to its approval of the Petitioner's affordable housing plan. The location and distribution of the affordable housing or other provisions for affordable housing shall be under such terms as may be mutually agreeable between Petitioner and the County of Maui.

Commissioner Ing moved on Docket No. A98-724 - Stanford S. Carr Development Corporation that the Commission accept his Proposed Decision and Order with the amendment to condition 1 as suggested by Commissioner Jarman and subject to sixteen (16) conditions. The motion was seconded by Commissioner Chun and polled as follows:

A representative from B.G. Equipment requested to have some documents entered into the record. Being that the hearing and action was over, the representative was given the opportunity to present oral testimony only.
