Prior to the granting of the first discretionary permit for the development of the single-family and multi-family residential development

described in paragraph 20 hereinabove or the hotel described in paragraph 21 hereinabove and by or before one year from the issuance date of this Decision and Order, Petitioner shall furnish the Commission with a letter from the County of Maui Board of Water Supply confirming that (a) the potable water allocation that will be credited to Petitioner will be available to and sufficient for the proposed project as it is described in the Petition, (b) the availability of potable water will not be an obstacle or impediment to the development of the proposed project as described in the Petition and (c) the proposed project as it is described in the Petition has been incorporated into the County Water Use and Development Plan for the area and that this plan will prevent the continued overpumping of the sustainable yield of the 'Iao aquifer."

Commissioners Mattson and Fiesta accepted Commissioner Catalani's amendment.

The motion to approve the Petition by Makena Resort Corporation subject to 22 conditions, as amended, was polled as follows:
