Bert Saruwatari, staff planner, oriented the Commission to the petition area on the Land Use District Boundaries and tax maps.

After hearing arguments, Ms. Ogata-Deal stated no objections to Petitioner's motion but requested that the Petitioner indicate how each of the conditions were satisfied and if any of the conditions were not applicable to this portion of Increment I, if Petitioner could explain the non-applicability of the conditions.

Mr. Shigemoto complied with Ms. Ogata-Deal's request and went over the conditions. Questions were then asked by Ms. Ogata-Deal and the Commissioners.

Presiding Officer Jarman announced that this matter before the Commission is a continuation of the hearing previously held on April 22 and 23, 1999 to reclassify approximately 210.471 acres of land currently in the Agricultural District into the Urban District at Kahului, Maui for expansion of Kahului Airport and facilities.

At the meeting held on April 22, 1999, the Commissioners deferred action on Intervenors' Motion to Disqualify pending legal opinions from the Attorney General's office and the Ethics Commission.

Presiding Officer Jarman entered the testimony of Margaret Sevilla into evidence.

Presiding Officer Jarman announced that the Commission received confidential memos from the Ethics Commission and the Attorney General's Office regarding participation in this docket. Since the Land Use Commission rules do not provide authority for the Commission to disqualify any one of its members, Presiding Officer Jarman informed the parties that the Commission will

treat this matter as separate requests to each of the identifying commissioners.

Arguments on the Motion to Disqualify were heard from Mr. Hall, Ms. Ogata-Deal, Mr. Zakian, and Mr. Ishida.

Deputy Attorney General Jon Itomura explained to the members of the audience the differences between disclosures, recusals and disqualifications. Mr. Itomura reported that based on the legal opinions received by the Ethics Commission and the Attorney General's Office, Commissioner Kelai was advised not to participate in the proceedings and that Commissioner Kelai has since recused himself from the proceedings. Based on Mr. Itomura's representation, Mr. Hall withdrew the Motion to Disqualify with respect to Commissioner Kelai.

Mr. Hall clarified that he chose not to amend his motion to disqualify to include Commissioners Catalani, Jarman and Fiesta. There were no objections from the parties regarding his clarification.

On behalf of Commissioner Kaopua, Mr. Itomura informed the parties that Commissioner Kaopua is still researching a couple of issues and needed more time to make a determination as to whether or not he will be participating in these proceedings. There were no objections from the parties to giving Commissioner Kaopua more time.

Based on the legal opinions of the Ethics Commission and the Attorney General's Office, Commissioner Desai expressed his position not to be recused. Commissioner Desai was questioned by the parties and by Mr. Itomura.

Further disclosures were made by Commissioner Yukimura.

On advice of Deputy Attorney Jon Itomura, the Commission did not vote on the motion to disqualify. Presiding Officer Jarman stated that Intervenor's Motion to Disqualify should be considered denied as to Commissioners Desai and Yukimura; postponed as to Commissioner Kaopua; and withdrawn as to Commissioner Kelai since Commissioner Kelai has recused himself. Mr. Hall objected to the denial of the motions and to the fact that no vote was taken on the motions.

It was determined by all parties that the Motions to Quash Subpoena Duces Tecum would be deferred subject to Intervenor's

condition that the motion be resolved prior to any of the people testifying who are the subjects of the subpoenas.
