A status report was given by Mr. Nunokawa. After hearing the status report, questions were asked by Ms. Ogata-Deal and the Commissioners. Mr. Wu briefed the Commission as to the Housing Finance and Development Corporation's role in this petition. Questions were asked by the Commissioners, comments were made by Mr. Zakian and Ms. Ogata-Deal.

Commissioner Ing moved that Petitioner report back to the Commission within one year or less on the status of all of Amfac's projects of West Maui. Commissioner Ing clarified that the status be limited to projects with respect to Docket No. A92-686. The motion was seconded by Commissioner Yukimura and unanimously approved by voice votes.

Commissioner Kelai excused himself from the hearing at this time.

ACTION AND CONTINUED HEARING

A92-684 - STATE OF HAWAII, DEPARTMENT OF TRANSPORTATION, AIRPORTS DIVISION (Maui)

Presiding Officer Catalani announced that this matter before the Commission is a continuation of the hearing previously held on May 6 and 7, 1999 to reclassify approximately 210.471 acres of land currently in the Agricultural District into the Urban District at Kahului, Maui for expansion of Kahului Airport and facilities.

Arguments on the Motion to Quash were heard from Mr. Hall, Ms. Ogata-Deal, Mr. Zakian, and Mr. Matsui. If Mr. Hall finds the documents produced by Mr. Matsui to his satisfaction, Mr. Matsui will withdraw their Motion to Quash. The County is still working on getting together their documents with respect to their Motion to Quash; therefore, their motion is still pending. Mr. Hall stated that they would like the County's documents before the witness testifies.

Presiding Officer Catalani announced the receipt of Petitioner's Sixth Amended Witness List. Mr. Matsui noted that Petitioner has deleted two of their witnesses, John Thatcher and Paul Casey; and added a representative of Maui Pineapple Company, Douglas Schenk, as a witness pursuant to the request of the Commission. Mr. Hall wanted to note for record that the prehearing order was clear as to not being able to add exhibits or witnesses after a certain date except for good cause. Mr. Matsui also introduced several exhibits that he wanted to reference in his cross examination of Mr. Schlapak. Having no objections from the State and County and having no objections in this instance from the Intervenor on the condition that if Intervenor needs to amend to add exhibits or witnesses to his case that the same courtesy be extended, Presiding Officer Catalani allowed Petitioner's amended exhibit and witness lists into the record.
