

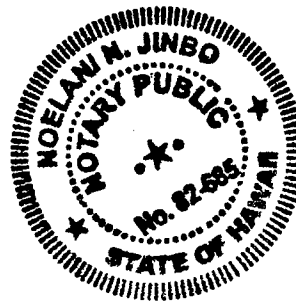



Deficiency judgment against Defendants HALE MUA PROPERTIES, LLC, a Hawaii limited liability corporation ("Defendant Hale Mua") and STERLING KIM ("Defendant Kim") shall be and is hereby entered in favor of Plaintiff SOUTHWEST 7, LLC, a Colorado limited liability company ("Plaintiff") as to the amounts stated herein.

Final judgment in favor of Plaintiff and against Defendant Hale Mua and Defendant Kim is hereby ENTERED pursuant to the Order Granting Plaintiffs' Motion for Deficiency Judgment as follows:

1. Plaintiff shall be and is hereby awarded the principal sum in the amount of \$1,337,302.00 (the remaining principal balance on the note of \$9,337,302.00 less the credit bid amount of \$8,000,000.00), interest and fees through May 31, 2011 in the amount of \$5,889,025.00, interest and fees accrued at the daily rate of \$6,225.00 from June 1, 2011 to November 16, 2011 in the amount of \$1,052,025.00, Commissioner's fees and costs of \$2,770.90, attorneys' fees in the amount of \$23,404.75, and legal costs in the amount of \$4,870.00, for the sum of \$8,309,397.65 entered against Defendant Hale Mua and Defendant Kim, jointly and severally; and

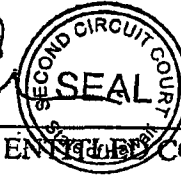

