On November 14, 2018, the State of Hawai'i Land Use Commission, filed its own Motion to correct a certain portion of the transcript of the Land Use Commission's hearing on subject petition on September 6, 2018 <sup>1</sup> ("Motion") per HAR §15-15-72, which was received by Petitioner on September 24, 2018..

At the September 6, 2018 meeting, Cindy Kester provided public testimony on behalf of Julia Alos. It was brought to the Commission's attention by public witness Cindy Kester via email on October 19, 2018 after her review of the transcript, that an error in the transcript

"Roundabout has now been constructed" should read "roundabout has <u>not</u> been constructed". The Court Reporter, Jean McManus was contacted and verified that an error had been made. At that time the Commission set a hearing date to formally correct the transcript on November 14, 2018.

for September 6, 2018's meeting in Kailua-Kona for Docket No. A06-767 Waikaloa Highlands had been discovered.

On the same day, LUC staff notified Court Reporter Jean McManus via email that there may be an error in the transcript of Ms. Kester's reading of Julia Aslo's testimony on Sept. 6, 2018. Page 13, Line 21. "Roundabout has now been constructed" should read "Roundabout has not been constructed".

Also on October 19, Court reporter Jean McManus reviewed her recording and confirmed via email that "not" was correct and that an error had been made; and that the written testimony read correctly and the transcript needed to be corrected to match.

On November 5, 2018, the Commission mailed the notice and agenda for its meeting via video conference on November 14, 2018 to the Statewide, Oahu, Maui and Hawai'i mailing lists designating agenda item V for the Commission to consider an action motion to correct the transcript accordingly.

The Commission considered its own Motion to Correct the transcript at its meeting on November 14, 2018 via video conference from video conference meeting rooms in Kahului, Maui; Honolulu, Oahu, and Hilo, Hawai'i. Dawn Takeuchi-Apuna, Esq. appeared on behalf of OP(in Honolulu); and, Ronald Kim, Esq., and Jeff Darrow appeared on behalf of the County (in Hilo).


Thereafter, a motion was made and seconded to correct the transcript.

There was no discussion on the motion, and a vote was taken on this motion. There being a tally of 5 ayes, 0 nays, and 3 excused, the motion carried.<sup>2</sup>
