STIPULATION REGARDING SETTLEMENT CONFERENCE

The undersigned parties, by and through their undersigned attorneys hereby stipulate and agree to the following:

1. The parties agree to attend a settlement conference to be facilitated by JONATHAN LIKEKE SCHEUER, Commissioner and Chairperson of the Land Use Commission.
2. The parties agree and authorize Mr. SCHEUER to schedule the date, time and place for the Settlement Conference, and to set the agenda for the Settlement Conference.
3. The parties waive any conflict or objection to the participation of Mr. SCHEUER or the staff of the Land Use Commission in or with respect to the Settlement Conference. The

involvement or participation of Mr. SCHEUER or the staff of the Land Use Commission shall not limit the participation or authority of Mr. SCHEUER, the staff of the Land Use Commission, or the Land Use Commission with respect to any matter now pending or which may be brought now or in the future before the Land Use Commission, including this docket.

4. All statements or communications made by any person or party in the Settlement Conference shall not be used or admitted in evidence in any proceeding before the Land Use Commission. The parties agree that the provisions of Rule 408 of the Hawaii Rules of Evidence shall apply to the Settlement Conference.

5. Participation in the Settlement Conference is strictly voluntary. Any person or party may terminate the Settlement Conference by giving written notice to all other parties and to the Land Use Commission through Mr. SCHEUER. The Parties also agree that Mr. SCHEUER may terminate the Settlement Conference and order or cause this docket to proceed on all matters then pending.

6. This Stipulation may be executed in counterparts.


