Hawaiian Memorial Life Plan, Ltd. is seeking to reclassify approximately 53.45 acres from the State Conservation District to the State Urban District in Ko`olaupoko, O`ahu, to allow for the expansion of the cemetery to meet future community needs for burial plots. The project would include approximately 28 acres for cemetery expansion, 3 acres of internal roadways, 7.75 acres of open space, and a 14.5 acre Cultural Preserve.
