hereby files its written status report for July 2017 pursuant to the Land Use Commission of the State of Hawaii Order Requiring Written Status Reports, dated May 28, 2014.

On June 20, 2017, Intervenors Ko Olina Community Association and Maile Shimabukuro (collectively "KOCA") filed its motion for recusal or disqualification of Honolulu Planning Commission ("Planning Commission") Chair Dean Hazama. On June 26, 2017, ENV filed its response, which takes no position on the relief requested by KOCA and expressly asserts that its statement of no position is not an indication of agreement with any aspect of KOCA's motion, and reserves the right to refute in future proceedings KOCA's characterizations and representations of facts related to the proceedings, including Mr. Hazama's statements during the August 17, 2016 and March 1, 2017 Planning Commission hearings, and statements attributed to Mr. Hazama in the Honolulu Star-Advertiser article published on August 19, 2016. Intervenor Colleen Hanabusa filed a renewal of objections to Mr. Hazama's participation and votes in the instant case and joinder to KOCA's motion. To date, KOCA's motion for recusal or disqualification of Mr. Hazama has not been scheduled for hearing.
