On November 13, 2017, Hawaiian Memorial Life Plan, Ltd. ("Petitioner") filed a petition

for land use district boundary amendment.

On December 11, 2017, Hui O Pikoiloa ("HOP") filed a timely Notice of Intent to

Intervene pursuant to Hawai'i Administrative Rules ("HAR") §15-15-52(b).

On October 10, 2019, Lianne Ching, Bettye Harris, Richard McCreedy, Juliane McCreedy, Jesse Reavis, Grant Yoshimori and Hui O Pikoiloa¹ (collectively "HOP")filed a timely Petition To Intervene In Hawaiian Memorial Life Plan, Ltd.'s Petition For Land Use District Boundary Amendment ("Petition To Intervene") pursuant to section 15-15-52, ("HAR").

In their Petition To Intervene, HOP stated that as owners of single-family residential lots that either abut or are within 400 feet of the Petition Area, they have a direct and indirect interest that is clearly distinguishable from the general public which would be adversely impacted by the proposed expansion of the Hawaiian Memorial Park Cemetery. HOP further asserted that some members of HOP exercise native gathering and access rights in the Petition Area and utilize Kāne ohe Bay for recreational purposes. HOP noted that the reclassification of the Petition Area will have an immediate and direct affect on owners of property who reside in close proximity to the Petition Area, including (1) an increased risk of flooding and similar hazards; (2) added risk of rock falls and mudslides; (3) impacts on native gathering and access rights for ahupua'a residents; (4) impacts on native plants and fauna; (5) increased construction traffic and noise; (6) loss of Conservation District lands; (7) adverse impact on the microclimate; (8) scenic resources and visual impacts; and (9) impacts on property values.

On October 15, 2019, Petitioner published a Notice of Hearing in newspapers of statewide circulation providing notice of a hearing scheduled for November 21, 2019.

On November 12, 2019, the Commission filed a meeting agenda and notice of hearing for November 21, 2019, in Kāne'ohe, Hawai'i, to the Statewide and O'ahu mailing and electronic mail lists, and the Lt. Governor's Office.

¹ Hui O Pikoiloa is an unincorporated community organization of concerned residents of the Pikoiloa Subdivision and other community members. Named individuals in the Petition To Intervene were Lianne Ching, Bettye Harris, Richard McCreedy, Julianne McCreedy, Jesse Reavis, and Grant Yoshimori.

The Commission considered the Petition To Intervene at its meeting on November 21, 2019, in Kāne'ohe, Hawai'i. Grant Yoshimori, Richard and Julianne McCreedy appeared on behalf of HOP. Curtis T. Tabata, Esq., and Jay Morford appeared on behalf of Hawaiian Memorial Life Plan, Ltd. ("Petitioner"). Dawn Takeuchi-Apuna, Esq., Rodney Funakoshi, and Lorene Maki appeared on behalf of the State Office of Planning ("OP"). Dina Wong and Ray Young appeared on behalf of the County.

The following commissioners made disclosure statements: Dawn Chang; Arnold Wong; Gary Okuda; and, Jonathan Scheuer. There were no objections to the commissioners' participation from any of the parties or the potential interveners.

There was no public testimony.

At the meeting, Mr. Yoshimori stated that he was the designated spokesperson for HOP. Mr. Yoshimori then elaborated on the nature and extent of HOP's interest in this matter and the effect the reclassification of the Petition Area would have on the group's interest. Mr. Yoshimori further explained that there are no other means of effectively protecting the interests of HOP as there are no other parties in the proceeding that effectively represent the interests held by HOP. Mr. Yoshimori also pointed out that HOP's intervention in the proceeding will result in the development of a complete record before the Commission and will serve the public's interest by ensuring that the concerns of the group are adequately represented. Mr. Yoshimori indicated HOP was willing to limit the scope of its intervention to the issues articulated in its Petition To Intervene and four additional issues: the need for the expansion; alternatives to expansion; compliance with State and county laws; and, impact to the climate. Finally, Mr. Yoshimori represented that if HOP was granted intervener status in this matter, he would be the spokesperson for the group with possible assistance from Richard McCreedy.

Following Mr. Yoshimori's presentation on HOP's Petition To Intervene, Petitioner stated that it did not oppose the intervention as long as it was limited in scope to the issues identified by HOP in its Petition to Intervene and the additional four issues raised by Mr. Yoshimori in oral testimony. In addition, Petitioner reserved the right to object during the course of the Petition.

The County had no objections to the Petition To Intervene and the proposed scope of intervention.

OP stated they had no objections to the Petition To Intervene and the proposed scope of intervention.

Following discussion, a motion was made and seconded to (i) grant the Petition To Intervene with respect to Hui O Pikoiloa, subject to the condition that the group shall be represented in all matters before this Commission by group members Grant Yoshimori with assistance from Richard McCreedy, on the grounds that HOP has demonstrated that they will be so directly and immediately affected by the proposed change that their interest in the proceeding is clearly distinguishable from that of the general public; that the position of HOP concerning the proposed change is not substantially the same as the position of a party already admitted in the proceeding; and that admission of HOP, subject to the above condition, will not render the proceedings inefficient and unmanageable; and, (ii) limit the scope of intervention to the nine issues raised by Hui O Pikoiloa in their Petition to Intervene and an additional four issues raised orally at the hearing. There being a vote tally of 7 ayes and 1 excused, the motion carried.²

² Currently there is one at-large position vacant on the Commission.

ORDER

This Commission, having duly considered the Hui O Pikoiloa's timely Petition To Intervene, the arguments of the parties presented in the proceeding, and a motion having been made at a meeting on November 21, 2019, in Honolulu, Hawai'i, and the motion having received the affirmative votes required by HAR §15-15-13, and there being good cause for the motion,

HEREBY ORDERS that Hui O Pikoiloa's timely Petition To Intervene be GRANTED with respect to Hui O Pikoiloa as an unincorporated association subject to the following conditions:

(1) that Hui O Pikoiloa shall be represented in all matters before this Commission by Grant Yoshimori and assisted by Richard McCreedy; and,

(2) that Hui O Pikoiloa's intervention shall be limited in scope to the following issues identified in the Petition to Intervene and as articulated at the intervention hearing:

a. Increasing flooding risks and similar hazards to nearby properties;

b. Adding risks of rock falls and mud slides in the area;

c. Impacts on native gathering and access rights for ahupua'a residents;

d. Impacts on native plants and fauna;

e. Increased construction traffic and noise;

f. Loss of conservation lands;

g. Adverse impacts to the microclimate;

h. Visual impacts;

i. Impacts to property values;

- j. Questions regarding the need for expansion;
- k. Alternatives to expansion;
- 1. Compliance with State and county laws; and,
- m. Impacts to climate.
