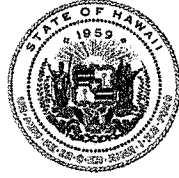


The State of Hawaii – Department of Defense – Hawaii Emergency Management Agency (HIEMA) concurs with siren site location designated as MA155, also known as the Kualono Subdivision-Pukulani Siren, further described on pages E3 and E4 on that certain Design Drawings for the Hanohano LLC - Kualono Subdivision-Pukulani Siren dated April 2019 (attached). HIEMA does not express any comment on any other page of said April 2019 Design Drawings submitted by Hanohano, LCC or its officers, employees, agents, contractors, and subcontractors' agents, subsidiaries to HIEMA.

Hanohano LLC and HIEMA mutually agree that Hanohano LLC will prepare a Non-Exclusive License and Conveyance Agreement between Hanohano LLC and HIEMA. Where in, Hanohano LLC grants to HIEMA, its officers, employees, agents, contractors and sub-contractors a nonexclusive license to operate, test, and maintain the Siren Improvements. Hanohano LLC will convey to HIEMA all Hanohano LLCs rights, permits, title and interest in and to all

improvements and equipment that constitutes the Siren Improvements. Hanohano LLC and HIEMA agree to diligently negotiate said Non-Exclusive License and Conveyance Agreement and no fee shall be charged by either party for said Non-Exclusive License and Conveyance Agreement.
