

ORDER DENYING PRINCEVILLE AT HANALEI'S
PETITION TO AMEND SPECIAL PERMIT

The petition filed by Princeville at Hanalei to amend SP80-349 by allowing a time extension and expanding the approved boundaries for the development of a golf course, together with the decision and record of the proceeding developed by the Kauai County Planning Commission, was received by the Land Use Commission on April 26, 1982. At its meeting on June 8, 1982 at Kahului, Maui, the Land Use Commission, having considered the record of the proceeding transmitted by the Kauai County Planning Commission and the Land Use Commission Staff Memorandum, determined that due notice of the meeting of the Kauai County Planning Commission to hear the petition was not published in accordance with HRS Section 205-6 and that the Planning Commission did not hold a public hearing as required by HRS Section 205-6, and did not make findings of fact and conclusions of law that the five requirements set forth in Land Use Commission Regulations, 5-2 have been met for granting a Special Permit for the lands proposed to be included in the golf course expansion.


It is therefore hereby ordered that the petition by PRINCEVILLE AT HANALEI to amend SP80-349 by allowing a time extension and expanding the approved boundaries for the development of a golf course be and the same is denied.




