On August 31, 2020, the State of Hawai'i Office of Planning ("OP") filed a

Motion for Reconsideration of the Findings of Fact, Conclusions of Law, and Decision

Order Dismissing The Office Of Planning's Motion For Reconsideration Of The Findings Of Fact,

Recommendation Of The County Of Maui Planning Commission To Approve A Fourth Amendment To

and Order Approving with Modifications the Recommendation of the County of Maui Planning Commission to Approve a Fourth Amendment to the Land Use Commission Special Permit ("Motion for Reconsideration"), pursuant to Hawai'i Administrative Rules ("HAR") § 15-15-84.

In its Motion for Reconsideration, OP requested that the State of Hawai'i Land Use Commission ("LUC") reconsider Condition No. 23 of the Findings of Fact, Conclusions of Law, and Decision and Order Approving with Modifications the Recommendation of the County of Maui Planning Commission to Approve a Fourth Amendment to the Land Use Commission Special Permit ("Decision and Order") filed August 13, 2020, to clarify whether the County of Maui Department of Environmental Management ("Applicant") is required to seek a district boundary amendment with the LUC for the approximately 22 acres of Important Agricultural Lands as currently stated in Condition No. 23, or for the entire special permit area of approximately 95.659 acres, or some other specific acreage of the special permit area. OP also stated that its preference is to request that the LUC delete Condition No. 23 altogether to re-establish that as a general policy, a special permit is a more appropriate mechanism than a district boundary amendment for the permitting of a landfill in the State Land Use Agricultural District.

On September 17, 2020, the Applicant filed a Joinder to OP's Motion for Reconsideration.

The LUC considered OP's Motion for Reconsideration at its meeting on September 24, 2020, using the Zoom Webinar Virtual Meeting platform. Dawn Apuna, Esq., appeared on behalf of OP. Richelle M. Thomson, Esq.; Eric Nakagawa; and Elaine Baker appeared on behalf of the Applicant. Michael Hopper, Esq.; Jordan Hart; and Kurt Wollenhaupt appeared on behalf of the County of Maui Department of Planning ("DP").

At the meeting, OP summarized why Condition No. 23 to the Decision and Order should be amended, or preferably deleted altogether.

Following discussion, a motion was made and seconded to dismiss OP's Motion for Reconsideration for lack of jurisdiction due to the untimeliness of its filing pursuant to HAR § 15-15-84(a). At this time, the LUC heard from the DP and the Applicant on OP's Motion for Reconsideration.

There being a vote tally of 8 ayes and 0 nays, the motion passed.1


The LUC, having duly considered the oral and written arguments of OP, the DP, and the Applicant in the proceeding, and a motion having been made and

seconded at its meeting on September 24, 2020, using the Zoom Webinar Virtual Meeting platform, and the motion having received the affirmative votes required by HAR § 15-15-13, and there being good cause for the motion,

HEREBY ORDERS that OP's Motion for Reconsideration be DISMISSED for lack of jurisdiction due to the untimeliness of its filing pursuant to HAR § 15-15-84(a).
