The State of Hawaii has denied to issue a State Permit that would allow the Durbins' to get a County of Hawaii Permit to build a home on their property.

No one can build a home on their property because the Department of Land and

Petitioner has attached <u>Exhibit I</u> of a letter from Attorney Melvin K. Soong of the Office of Finseth & Soong, Attorney-at-Law, of Honolulu, Hawaii on the Russell E. Orrs' request to evaluate the State of Hawaii Land and Natural Resources denial of their request to build a home on their property.

As you will see Attorney Soong told them that the Land and Natural Resources Board denied them a permit because they said the proposed use is more appropriately compatible with agricultural zoning, considering its present use as well as the surrounding land use and the Russell E. Orrs' would have to have their property rezoned inorder to build on said land. Attorney Soong told them it would be better to get a group of property owners rather than just do their own piece of property.

THEREFORE, Petitioner PARADISE HUI HANALIKE ASSOCIATION, acting on behalf of all the above said property owners respectfully requests an amendment of the Land Use District Boundary in Hawaiian Paradise Park, Keaau, Puna, Hawaii in the County of Hawaii, Island of Hawaii, from its present classification in a Conservation District to a Agriculture District because of the facts established in this report, in that the proposed use of this land is more appropriately compatible with agricultural zoning, considering its present use as well as the surrounding land use.
