CERTIFICATE OF SERVICE

5. At least six opportunities for larger community engagement on the proposed Project have been provided. Three of these opportunities have been informational meetings held by Petitioner.

6. First, Petitioner held an initial community informational meeting on August 1, 2016. One-hundred and two participants attended.

7. Second, Petitioner held a second community informational meeting on November 12, 2018. Sixty-five participants attended.

8. Third, during the draft environmental assessment (“*DEA*”) process, a public meeting was held in connection with the Lāna‘i Planning Commission’s consideration of the Project on January 20, 2021.

9. Written public comments were received during the *DEA* comment period. Petitioner also solicited and received written comments from interested State and County agencies.

10. Fourth, Petitioner held a third community informational meeting on February 22, 2021. Ninety-six participants attended.

11. Fifth, during the Maui County Council Affordable Housing Committee’s (“*Committee*”) consideration of Bill 10 (2021) on March 5, 2021, the community voiced support for the Project through oral and written public testimony.

12. Sixth, the Committee held two rounds of public testimony on the Project during its consideration of the 201H application. The first round was held during the August 2, 2021 meeting of the Committee. The second round was held during the August 16, 2021, meeting of the Committee.
