Dear members of the Land Use Commission:

Thank you for taking written testimony re Pūlama Lāna'i's Hōkūao 201H Project. I am not a lobbyist; I am writing on my own behalf, as a resident of Lāna'i.

I grew up on Lāna'i, back in the late seventies to early eighties, and housing on the island then – let alone affordable housing – was scarce. I cannot speak to the situation on other islands in our state, but I am aware that affordable housing is an issue there, as it is here.

The inventory of homes to rent and/or buy on Lāna'i has always been scarce. There have always been young families arriving from somewhere else, in this case, from the Philippines, and needing to rely on the kindness of their in-laws or relatives fortunate enough to have a home, into whose rooms these families were crammed, while they waited for a house to become available to rent. I was part of that young family from the Philippines. It was a narrative that was as commonplace as it was inescapable.

The housing crisis, the lack of housing, remains the same, then, as now. What has changed is the make-up and skill set of the workforce. Gone are laborers called to Lāna'i to work in the pineapple fields. Now Lāna'i's workforce is comprised of teachers and construction crews, new hires for the island's resorts. It is a housing crisis that affects hundreds of individuals and families on this island. The narrative remains largely the same.

But now before you is an opportunity to change the narrative, for our island and its residents.

I fully support the Hōkūao affordable housing project. I fully support amending the agriculture land use district boundaries into the urban land use district for roughly seventy-six acres of land. I cannot think of a better use of land than for constructing affordable homes to rent for our growing workforce. Passage of the Hōkūao affordable housing project would free up other rental units. Approving Hōkūao would mean significantly improving the quality of life for families and couples and individuals who see enough promise and potential to want to settle on Lāna'i and call this place home.

I wish you all clarity of mind as you discuss and weigh and read testimonies and consider housing and the future of Lāna'i's residents.

Dear LUC Commissioners,

I am writing in support of the Hokuao Affordable Rental Housing Development project on Lanai.

My name is Alice Granito and I have been a resident of Lanai since 2003. I worked at the only licensed preschool on the island for 14 years. Currently, I work for the State of Hawaii - Child Welfare Services.

When I first moved here, I was ok with living with my significant other and his family. As time went on, more family members joined the household. With 8 people, we live in an old plantation home with one bathroom. Usually, this living situation is interesting to say the least, but during this pandemic it has been difficult living in a multi-generational home with one bathroom. We have all had to make extra sacrifices to care for everyone in our household. With only one bathroom there is no option for isolation in the event anyone was to get sick, so we are extra diligent with our contact with people outside of the home.

During my time here I've applied for housing through Castle and Cooke and then Pulama Lanai at various times. I admit that I haven't been aggressive in my search for housing, but when I did, I was left discouraged. The first time I applied, I was called for housing, but at the time I was unable to afford living expenses plus the higher rent on my own versus living at home. Most recently, I applied for housing with Pulama Lanai and my application was accepted. I waited two months for a response before I was finally notified that they were unable to offer me housing. The notice also stated that Pulama Lanai was not accepting any applications until further notice. This was a letdown as it is difficult to live on your own here with limited resources for housing.

Private rentals are expensive and limited, adding to the housing shortage on Lanai. Off-island contractors can pay higher than market rent. I don't blame private homeowners for wanting to take advantage of the extra income, but I would never be able to compete with the off-island contractors that are able to pay thousands of dollars a month for rent.

These factors make it extremely frustrating to live here. I've come to love Lanai and would love to enjoy my life here, but the lack of housing options has me considering life elsewhere. The Hokuao Affordable Rental Housing Development gives me hope for the future. This will ease stress to families living in multi-generational and multi-family homes. I personally look forward to having the option to move into a single-family home on my own.
