# ORDER GRANTING MOTION FOR ORDER PERMITTING PETITIONER TO ASSIGN ITS INTEREST IN DOCKET NO. A93-696 TO KUKUI`ULA DEVELOPMENT COMPANY (HAWAII), LLC

On March 31, 2003, Kukui`ula Development Company, Inc., a Hawai`i corporation ("Petitioner"), filed a Motion For Order Permitting Petitioner To Assign Its Interest In Docket No. A93-696 To Kukui`ula Development Company (Hawaii), LLC ("Motion"), pursuant to sections 15-15-70, Hawai`i Administrative Rules ("HAR"). Petitioner requested that the Land Use Commission ("Commission") grant its request to i) transfer its rights and interest derived under the subject docket to Kukui`Ula Development Company (Hawaii), LLC, a limited liability company; and ii) authorize the amendment of the subject docket by replacing Petitioner with Kukui`Ula

Development Company (Hawaii), LLC, and to amend the existing tax map key designation with the current updated tax map key designation of the Petition Area.<sup>1</sup>

On June 9, 2003, the Office of State Planning ("OP") filed a Statement Of Position In Support Of The Motion.

The Commission considered the Motion at its meeting on July 10, 2003, in Honolulu, Hawai`i. Benjamin M. Matsubara, Esq., appeared on behalf of Petitioner.

John W. K. Chang, Esq., appeared on behalf of OP and Laurel Loo, Esq., appeared on behalf of the County of Kaua`i Planning Department. At the meeting, Commissioner Sakumoto stated that his law firm represents one of the principals of Kukui`Ula Development Company (Hawaii), LLC, and he therefore recused himself from participating in this docket. None of the parties raised any objection to Petitioner's Motion.

Following discussion, a motion was made and seconded to grant Petitioner's Motion. There being a vote tally of 6 ayes, 1 excused, and 2 absent, the motion carried.
