Commissioner Himeno moved to issue a Declaratory Order that under 205, H.R.S., the slaughterhouse is a permissible use on agricultural land. The motion was seconded by Commission Tamaye.

Cynthia Thielen raised a possible conflict of interest concerning Commissioner Suzuki.

Commissioner Suzuki moved for an executive session to discuss legal matters with the Deputy Attorney General. The motion was seconded by Commissioner Himeno and carried unanimously by voice votes.

Commissioner Suzuki excused himself from the proceedings.

Vice-Chairman Whittemore announced that the Commission did not have a quorum to vote on this petition and action was deferred until January 20, 1988.
