Commissioner Yuen moved to approve a portion of the petition submitted by the Department of Planning and Economic Development on behalf of the Hawaii Ocean Science and Technology Park to reclassify approximately 500 acres at Keahole, North Kona, Hawaii, identified as portions of Hawaii Tax Map Key Nos.: 7-3-9: portion of parcel 5 and 3 from the Conservation District to the Urban District subject to the following conditions:

- 1. The Petitioner shall develop the property as a research and technology park for ocean-related science and technology users, which users shall be limited to industries promoting or providing research, the development and commercial application of technology, intensive activities that utilize ocean water as a resource or depend on proximity to the ocean, including aquaculture, mariculture and ocean-related activities.
- 2. Prior to any construction activity, the Petitioner shall submit to the Department of Land and Natural Resources' Historic Preservation Office a satisfactory historic preservation plan, which will include appropriate measures to preserve the Mamalahoa Trail and all sites deemed appropriate for preservation by a qualified archaeologist to be employed by the Petitioner.
- 3. Petitioner shall submit to the Commission a metes and bounds map reserving approximately 47 acres in the green portion of Exhibit 20B running along the shoreline in the Conservation District; an 80-foot strip along or including the existing roadway which will be necessary for Petitioner's road and cold-water and return pipelines, and areas from the roadway to the ocean leaving sufficient room for the cold-water pipeline intake and outflow sources that would be developed at Wawaloli Beach would be reclassified to the Urban District. The remaining acreage

on both sides of that pipeline site would be left in Conservation. The motion was seconded by Commissioner Cuskaden

Commissioner Cuskaden moved and Commissioner Yuen seconded to go into executive session. The motion was carried by voice vote.

The Commission resumed the discussion on the motion after seeking advice from legal counsel. Commissioner Cuskaden proposed an amendment to the motion, to delete Condition Number 3, which reserved the approximate 47 acres in Conservation and reclassifying the approximately 80-foot strip with the roadway and pipes. The amendment is to continue to reserve the approximate 47 acres including the roadway and pipeline areas in the Conservation District and to reclassify the remaining approximately 500 acres of the land from Conservation into Urban. The motion was seconded by Commissioner Whittemore. Commissioner Cuskaden further clarified the condition by adding that a 300-foot setback in Conservation be established from the beach line, and that Petitioner submit a new map to reflect this 300-foot setback. The amendment was passed by voice vote.

The main motion of approval of approximately 500 acres as well as the three conditions were unanimously passed with the following votes:
