#### ACTION

#### A89-640 - HALEKUA DEVELOPMENT CORPORATION (Oahu)

Chairman Nip announced that the Commission would take action in the matter of the petition by Halekua Development Corporation to consider reclassifying 161.1 acres of land currently in the Agricultural District into the Urban District at Hoaeae and Waikele, Ewa, Oahu for a golf course complex and tennis courts.

Commissioner Kajioka was excused from this proceeding due to a previously declared conflict of interest.

Arguments were heard from Jan Sullivan, Betsy Marcinkus, and Ann Ogata-Deal. After hearing arguments, questions were asked by the Commissioners.

It was determined by Chairman Nip that all of the Commissioners present were eligible to participate in the action on the petition.

Commissioner Hoe moved to grant the petition by Halekua Development Corporation to reclassify approximately 161.1 acres of land currently in the Agricultural District at Hoaeae and Waikele, Oahu for a golf course complex and tennis courts subject to thirteen conditions. And further, that the findings, conclusions and conditions as set forth by stipulation between the parties be adopted. The motion was seconded by Commissioner Whittemore.

The motion to approve the petition subject to thirteen conditions was polled as follows:

# A86-600 - WAITEC DEVELOPMENT, INC. (Oahu)

Chairman Nip announced that the Commission would take action in the matter to consider Petitioner's Motion to Amend Findings of Fact, Conclusions of Law, and Decision and Order which reclassified approximately 547.5 acres of land from the Agricultural District into the Urban District at Waikele and Hoaeae, Oahu for a residential community.

Commissioner Kajioka was excused from this proceeding due to a previously declared conflict of interest.

Commissioner Hoe moved to grant Petitioner's request to release Condition #2 which, in general, requires Petitioner to coordinate the development with the Department of the Navy and requires Petitioner to construct a berm bordering the designated blast zone area. The motion was seconded by Commissioner Himeno and unanimously carried by the following voice votes:

Ayes: Commissioner Hoe, Chun, Himeno, Lapenia, Shinno, Wada, Whittemore, and Chairman Nip.

Commissioner Himeno was absent from the proceeding at this time.

# A89-637 - ATPAC LAND COMPANY LIMITED PARTNERSHIP, WAIKOLOA DEVELOPMENT COMPANY, AND WAIKOLOA LAND AND CATTLE COMPANY (Hawaii)

Chairman Nip announced that the Commission would take action in the matter of the petition by Atpac Land Company Limited Partnership, Waikoloa Development Company, and Waikoloa Land and Cattle Company to reclassify approximately 853.187 acres of land currently in the Agricultural District into the Urban District at Waikoloa, South Kohala, Hawaii for resort, residential, 3 golf courses, and commercial uses.

Arguments were heard by Mr. Funaki, Mr. Kanuha, and Mr. Anderson. After hearing arguments, questions were asked by the Commissioners.

It was determined by Chairman Nip that all of the Commissioners present were eligible to participate in the action on the petition.

Commissioner Lapenia moved to approve the petition by Atpac Land Company Limited Partnership, Waikoloa Development Company, and Waikoloa Land and Cattle Company subject to the twelve conditions and Condition Number 13, that "The Commission may fully or partially release these conditions as to all or any portion of the property upon timely motion and upon the provision of adequate assurance of satisfaction of these conditions by the Petitioner.

The motion was seconded by Commissioner Whittemore.

Chairman Nip moved to amend Condition Number 12 to read as follows: "Petitioner shall give notice to the Land Use Commission, the Office of State Planning, and the County of Hawaii Planning Department of any intent to sell, lease, assign, place in trust, or otherwise voluntarily alter the ownership interest in the Property covered in the Petition, prior to development of the Property and shall provide evidence that any successor in interest has a willingness and ability to develop the Property in substantial compliance with representations made to the Commission in obtaining the

reclassification of the Property in concert and in compliance with the conditions herein." The motion to amend Condition Number 12 was seconded by Commissioner Lapenia.

The motion to approve the petition subject to thirteen conditions as amended was approved as follows:

Ayes: Commissioner Lapenia, Hoe, Kajioka, Shinno, Wada, Whittemore, Chun, and Chairman Nip.

Commissioner Himeno joined the proceeding at this time.

# A89-641 - STATE OF HAWAII, DEPARTMENT OF TRANSPORTATION AIRPORTS DIVISION (Hawaii)

Chairman Nip announced that the Commission would take action in the matter of the petition by the Department of Transportation, Airports Division to consider reclassifying 548.16 acres of land currently in the Conservation District into the Urban District at Keahole, North Kona, Hawaii for airport expansion and development of new facilities.

Commissioner Kajioka and Commissioner Chun were excused from this proceeding due to a previously declared conflict of interest.

Commissioner Lapenia moved to accept the Hearing Officer's recommendation to approve the petition by the Department of Transportation subject to seven conditions, as amended. To address the County of Hawaii's concern, Condition Number 3 is amended to read as follows: "Petitioner shall monitor vehicular traffic attributable to the development proposed in the petition area at on-site and off-site locations, and shall undertake subsequent mitigative measures that may be required in coordination with the Department of Transportation, Highways Division."

Vice-Chairman Chun announced that the Commission would take action to consider Petitioner's Motion for Clarification of Decision and Order which reclassified approximately 299.79 acres of land from the Agricultural District into the Urban District at Kalapaki, Lihue, Kauai for resort.

Commissioner Hoe moved to clarify the Decision and Order dated February 17, 1988 to read as follows:

"Condition Number 1 is clarified to allow the porte cochere of a restaurant and a portion of a parking lot of Petitioner's proposed Phase IV hotel to be located on the Property."

"Condition Number 2: Property owner as referred to in Condition No. 2 is clarified to mean not only the Petitioner but includes all holders of real property interests in the property. The intent is that the avigation easement is to run with the land."

"Condition Number 3: Is clarified and amended to read: The Petitioner shall execute appropriate documents and/or agreements with the State Department of Transportation, binding upon itself, its successors and assigns, that would indemnify and hold harmless the State of Hawaii and all of its agencies and/or employees from any injury, damages, and costs, including, but not limited to, reasonable attorney's fees arising from any action alleging adverse impacts generated by normal airport activities at the Lihue Airport filed by any owners, subtenants, guests, or other users of the Property."

The motion was seconded by Commissioner Kajioka and unanimously carried by voice votes.

A lunch recess was taken at 12:00 p.m. to reconvene at 1:45 p.m.
