### A83-554 - FARMS OF KAPUA

Following a short recess, Chairman Yuen announced that the Commission will now go into executive session to receive counsel from its Deputy Attorney General before taking action on the request by intervenors Pa'apono of Milolii to amend the condition in the Commission's Decision and Order.

Chairman Yuen reported that the Commission had received counsel from its special Deputy Attorney General Benjamin Matsubara regarding the legality of certain aspects of the request by intervenors.

Commissioner Rubin moved that the motion be denied, seconded by Commissioner Choy, and the motion was carried by voice vote.

# A84-584 - EDWARD P. PERREIRA, ET AL

In the matter of the petition by Edward P. Perreira, et al to reclassify approximately 3.99 acres of land from the Rural District into the Urban District at Haiku, Maui for a residential subdivision, a hearing had been conducted by Hearing Officer Benjamin Matsubara on February 26, 1985.

Mr. Matsubara reported on his findings which had been presented at the hearing, and recommended that the petition be approved.

Commissioner Suzuki moved to approve A84-584, consisting of approximately 3.99 acres of land situated at Haiku, Maui, from the Rural District into the Urban District. It was seconded by Commissioner Whittemore and carried by voice vote.

#### A84-586 - MASAAKI & MASUYO DOI

In the matter of the petition by Masaaki and Masuyo Doi to reclassify approximately 3.25 acres of land from the Agricultural District into the Rural District at Haiki, Maui, a hearing had been conducted by Hearing Officer Benjamin Matsubara on February 26, 1985.

Vice Chairman Tacbian moved to approve Docket A84-586, consisting of approximately 3.25 acres of land at Pa'uwela, Maui from the Agricultural District into the Rural District, on the condition that the initial conveyance be to the immediate family members. It was seconded by Commissioner Suzuki.

Commissioner Choy felt that the condition regarding the conveyance to family members should not be a part of the motion since it would appear that the Commission was overstepping its jurisdiction on a small parcel.

Commissioner Rubin supported the motion as stated by Vice Chairman Tacbian.

The Chair called for a vote on the inclusion of the condition in the motion, and it was carried with Commissioner Choy casting the only dissenting vote.

The Commission was next polled on the motion to approve the petition with the condition, and the motion was passed with Commissioner Choy dissenting.

Mr. Murakami was also reminded that affidavits of the three witnesses who were presented on video tape but were not sworn in, will be due within five working days.

This concluded the protracted hearing on this petition which had spanned a period of nearly a year. At this time, post hearing requirements and procedures were outlined.

Chairman Yuen expressed his appreciation to allopresent for their tremendous patience in allowing the Commission to conduct the longest LUC hearing on record, and to all of the parties for their cooperation and the professional manner in which this decision-making process was conducted. He also thanked the people of Waianae for enabling the Commission the opportunity to take into account their concerns and needs through the hearing process.
