### CONTINUATION OF HEARING OF JANUARY 15, 1976

### A75-405 - KULA ALII, LTD.

Chairman Tangen announced that the hearing today was a continuation of the hearing which had been called by the Commission on January 15, 1976 pursuant to a notice published in the Maui News and the Honolulu Star Bulletin on December 16, 1975.

Correspondence and documents received subsequent to January 15, 1976 were identified as follows:

1. Letter dated February 4, 1976 from Michael A. Town indicating that he and his wife wished to intervene in the proceedings on this docket

- 2. Petition to Intervene; Affidavit in Support of Late Filing; and a Certificate of Service dated February 11, 1976, submitted by Michael A. Town
- 3. Appearance of Counsel; Opposition to Petition to Intervene; Certificate of Service filed by William F. Crockett, attorney for Kula Alii, Ltd., dated February 17, 1976
- 4. Letter dated February 23, 1976 from C. Earl Stoner, Jr., requesting prehearing conference
- 5. Undated letter received on March 2, 1976 from Michael Town applying to be a witness in the hearing on Docket A75-405

At the Chairman's request, parties who had been admitted on January 15, 1976 identified themselves as follows:

- 1. Gilbert Lee, Deputy Attorney General, representing the Department of Planning and Economic Development
- 2. Tosh Ishikawa, Planning Director, Maui Planning Department
- 3. William Crockett, attorney, representing Kula Alii, Ltd.

The Chair also noted the presence of Mr. Michael A. Town.

As indicated during the prehearing conference held on March 15, 1976, Mr. Crockett made an oral request for leave to amend the petition. He added that this will be followed up by a formal written request. Mr. Crockett explained that the substance of the amendment involved the inclusion of parcels 17 and a portion of 18, Tax Map Key 2-2-16, in the petition. He called on Mr. Earl Stoner to identify these parcels on the map.

Chairman Tangen advised that it had been ruled by the Attorney General's office that since the requested amendment involved a substantial land area, it will be necessary to re-advertise the hearing. At that time, Mr. and Mrs. Town will have an opportunity to make a timely application to intervene. The Chair also ruled that the \$50 filing fee will be required to defray publication costs for the notice of hearing.

Since there were no objections from the Commissioners, Chairman Tangen granted the petitioner's motion to amend the petition. Mr. Town stated that he also had no objections. Chairman Tangen announced it had been suggested that the Commission, staff and any interested parties take a field trip to view the subject site. No objections were raised by any of the parties.
