A80-477 - MANOA FINANCE COMPANY, INC.

Declaration by Commissioner Yuen

For the record, it was stated by Commissioner Yuen that several years ago he had represented certain individuals in a lawsuit filed against the petitioner, Manoa Finance Co. However this matter was amicably settled out of court. Thus, he did not believe that this would disqualify him from participating in the proceedings today.

Commissioner Whitesell moved that Commissioner Yuen be permitted to participate in these proceedings. It was seconded by Commissioner Pascua and unanimously carried.

Public Witness

Senator Neil Abercrombie, representing the Sixth District, testified before the Commission as a public witness.

Motion in Opposition to Petition for Intervention by Pinao Tenants' Association - By Francis Izumi, Representing Petitioner

It was moved by Commissioner Yanai, seconded by Commissioner Oura, and unanimously agreed to go into executive session to receive counsel regarding the above motion.

The Commission was in executive session from 9:54 a.m. to 10:20 a.m.

Counselor Kawada explained that discussion during the executive session had focused on the question of defective filing as alleged in petitioner's motion to oppose intervention on the basis of lack of verification, untimeliness and method of service.

Chairman Duke ruled that the verification was being made a part of the original intervention request and therefore considered as having been filed in a timely fashion.

Commissioner Yuen moved, seconded by Vice Chairman Nakagawa, to deny petitioner's motion in opposition to petition for intervention by Pinao Tenants' Association. The motion was carried with the following votes:

Nays: Commissioners Oura, Pascua

Commissioner Yuen moved to deny the petition to intervene by the Pinao Tenants' Association which was seconded by Commissioner Pascua.

Commissioner Yuen elaborated on his reasons for the motion. Commissioner Whitesell, Vice Chairman Nakagawa and Chairman Duke spoke in opposition to the motion.

The motion was defeated as follows:

Nays: Commissioners Yanai, Miyasato, Whitesell, Nakagawa, Chairman Duke

Vice Chairman Nakagawa moved to approve the petition for intervention by the Pinao Tenants' Association as permitted under Section 6-7 (1) (d) of the Commission's Rules. The motion was seconded by Commissioner Whitesell and unanimously carried.

Chairman Duke directed Counselor Schweigert to prepare the decisions and orders reflecting the Commission's action on the petitioner's motion to deny the intervention request and the petition for intervention by the Pinao Tenants' Association.
