HEARING

A79-453 - THE STATE LAND USE COMMISSION

Pursuant to a notice published in the Honolulu Advertiser and the Garden Island on July 20, 1979, and notices sent to all parties, a hearing was called by the Land Use Commission in the matter of the petition by the Land Use Commission to amend the land use district boundaries for "A", approximately 2.9 acres of land and "B", approximately 1.3 acres of land presently in the Agricultural District into the Urban District at Kilauea, Hanalei, Kauai, Docket No. A79-453. The hearing was conducted by Mr. Benjamin Matsubara who was appointed by the Commission as the Hearing Officer for the subject petition.

The Hearing Officer called on staff to orient the parties to the location of the petitioned property on the maps.

INTERVENOR

Mr. Walton Hong, attorney representing Rex Financial Corp. and Roger Taniguchi, owners of parcels "A" and "B" respectively, stated that he had been under the erroneous impression they were automatic parties to the proceedings on this petition. Since there were no objections from any of the parties, Mr. Hong was admitted as a party. Mr. Matsubara noted for the record that intervenors will be identified as "intervenor-landowner".

Petitioner's Exhibit 1 was moved into evidence. Additionally, Mr. Kawada requested that the proceedings and transcript of the petition by Rex Financial Corporation, Docket A76-425, be incorporated by reference as a part of this petition.

Mr. Belles objected to the incorporation of the proceedings of Docket A76-425 as they pertained to parcel "B", since much of the testimony introduced in favor of the change for that parcel would not necessarily relate to the parcel being considered under the present petition.

The Hearing Officer declared that he will review those portions of Docket A76-425 which he finds relate to present petition for judicial purposes.
